May kindly see the letter dated 24.10.2017(flag 'A') received from Smt. Anuradha Pundir, Secretary, District Legal Authority, Hardoi ^{Service} regarding submission of statements of movable and immovable properties acquired/held by her or by any member of her family for the financial years 2014-15 and 2015-16 in prescribed proforma to this Court for kind perusal and information as required by the Court's circular letter No.16/IV-h-16/Admin.(A), dated 13.5.2004.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by her are given below:-

(1) In the financial year, 2014-15, Smt. Pundir's income from salary and other sources is Rs.17,60,149/- (RS.16,33,937/- from gross Salary and Rs.1,26,212/- from Redemption of Mutual fund) from this amount, she has paid Rs.1,58,126/- against New Pension Scheme, Rs.6,800/- against GIS, Rs.2,20,978/- against Income Tax, Rs.1,00,000/- against PPF, Rs.125004/- against Mutual fund and Rs.33890/- against LIC. As such, total deductions /Savings /investment is Rs.6,44,798/-. The balance of her Saving Bank Account(s)/Post office account decreased for Rs.30,876/- in this financial year. Thus a sum of Rs.11,46,227/- was therefore available with her to meet out the household expenditure of her family consisting of four members.

(2) In the financial year, 2015-16, Smt. Pundir's income from salary and other sources is Rs.12,77,832/- (Rs.11,86,277/- from gross Salary and Rs.91,555/- from surrendering of Mutual fund) from this amount, she has paid Rs.85,421/- against New Pension Scheme, Rs.4800/- against GIS, Rs.1,39,958/- against Income Tax, Rs.1,50,000/- against PPF, Rs.1,40,004/- against Mutual fund and Rs.23,890/- against LIC. As such, total deductions /Savings /investment is Rs.5,44,073/-. The balance of her Saving Bank Account(s)/Post office account decreased for Rs.5,154/- in this financial year. Thus a sum of Rs.7,38,913/- was therefore available with her to meet out the household expenditure of her family consisting of four members.

It is pertinent to mention here that the husband of the officer Sri Abhay Pratap Singh, is also a Judicial officer posted in the same Judgeship whose annual income is Rs.14,47,923/- and Rs.12,42,101/- in respective financial years.

In this connection, it is submitted that Smt. Pundir has already submitted her property statement upto financial year 2013-14 which has already been seen by Hon'ble Mr. Justice Abhinava Upadhyaya, Administrative Judge, Etawah Judgeship . . . 2

on 17.10.14 at flag 'Z' and the said statement is at flag 'M'.

The movable and immovable property statement for the financial years 2014-15 and 2015-16 has been submitted by the officer vide her letter dated 24.10.17 (flag 'A') which was due to be submitted in third financial year 2014-15 i.e. on or before 31.3.2017. As such there is delay in submission of the aforesaid Property statement from the part of the officer.

May, if approved, the statements of movable and immovable property for 2014-15 and 2015-16 of Smt. Anuradha Pundir, Secretary, District Legal Service Authority, Hardoi may kindly be laid before Hon'ble Mr. Justice Mahendra Dayal, Administrative Judge, Hardoi Judgeship for His Lordship's kind perusal and orders?
