May kindly see the letter, placed below at **flag 'A'**, received from Smt. Anuradha Pundir, Secretary, Chief Judicial Magistrate, Pilibhit regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by her or any member of her family for the financial years 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

(2) In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2016-17 and 2017-18 of the officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

(1) In the financial year 2016-17, income from salary is Rs.12,71,073/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF a/c, LIC, Mutual funds is Rs.7,22,167/-. The balance of her savings bank account(s) reduced for Rs.1,12,666/- this financial year from previous year's balance. Thus, a sum of Rs.6,61,572/- was therefore available with her to meet out the household expenditure of her family consisting of four members in whole of the financial year.

It is pertinent to mention here that her husband is Additional District & Sessions Judge/F.T.C., Hardoi having annual income of Rs.12,69,315/-.

(2) In the financial year 2017-18, income from salary is Rs.13,74,665/-, received matured amount of Mutual Fund & NSC is Rs.4,505/- & Rs.1,66,504/- respectively. Thus, the total income is Rs.15,45,674/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF a/cs, LIC, Mutual funds and the balance of her savings bank account(s) enhanced for Rs.81,347/- this financial year from previous year's balance, total of which is Rs.5,06,283/-. Thus, a sum of Rs.10,39,391/- was therefore available with her to meet out the household expenditure of her family consisting of four members in whole of the financial years.

It is pertinent to mention here that her husband is Additional District & Sessions Judge/F.T.C., Hardoi having annual income of Rs.14,59,305/-.

In this connection it is submitted that Smt. Anuradha Pundir has already submitted her property statement upto the financial year 2015-16 (statement is at **flag 'M'**) which had already been seen by Hon'ble Mr. Justice Mahendra Dayal, the then Administrative Judge, Hardoi at **flag 'Z'**.

It is further submitted that as per policy/Court's Circular Letter, the officer has

to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., in 2018-19 up to March 2019. She has submitted the movable and immovable property statement for the financial years 2016-17 & 2017-18 vide her letter dated 15.05.2019 (at flag 'A'). As such, there is no delay in submitting the aforesaid property statements from the part of the officer.

May, therefore, if approved, property statements for the financial years 2016-17 and 2017-18 alongwith letter dated 15.05.2019 (at flag 'A') of Smt. Anuradha Pundir, Secretary, Chief Judicial Magistrate, Pilibhit be laid before Hon'ble Mr. Justice Pankaj Naqvi, Administrative Judge, Pilibhit Judgeship for His Lordship's kind perusal and orders?
