May kindly see the letter, placed below at flag 'A', received from Sri Amarjeet, Additional Chief Judicial Magistrate, Allahabad regarding issuance of 'No Objection Certificate'/'Identity Certificate' for obtaining Passport.

In his letter, Sri Amarjeet has stated that he has to apply for passport for which 'Identity Certificate' and permission of Hon'ble Court is required. He has enclosed four passport size photographs of himself and required 'Affidavit' (flag 'B') in connection with declarations as per G.O. and Section 6 (2) of Passport Rules. His dependent is Km. Kavya Khokher (Daughter). He has, therefore, requested to place the application before the Hon'ble Court so that he can apply for a passport in the near future.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). He has requested for the same from the Court. Here, it is further to be submitted that as per reports, placed below, one Vigilance enquiry is pending against Sri Amarjeet. According to the Para 5 (1) of G.O no. 1/3/98/-Ka Prasko./1999 dated 14.06.1999 (copy at flag 'C'), if any disciplinary proceeding is pending against a government servant, decision will have to be taken by the competent authority, for grant of permission for foreign visit to the government servant, seeing all the facts, and as per note mentioned on 4th page of the G.O. dated 14.06.1999, same process has to be adopted in the matter of issuance of 'No Objection Certificate', now 'Identity Certificate' in favour of a government servant for obtaining Passport. In the instant case, as there is one Vigilance enquiry pending against the officer, matter for issuance of 'Identity Certificate' in favour of the officer for obtaining Passport, is on the discretion of Hon'ble the Administrative Judge, Allahabad Judgeship, who is the competent authority in the same matter.

Under the facts and circumstances, mentioned above, if approved by Hon'ble Mr. Justice Dilip Gupta, Administrative Judge, Allahabad Judgeship, the 'Identity Certificate' at flag 'D' be issued, in duplicate, in favour of Sri Amarjeet, Additional Chief Judicial Magistrate, Allahabad, as requested, for obtaining Passport with the direction that he should take prior permission of the Court before proceeding abroad?
