अतः आपसे सादर आग्रह करना है कि कृपया मेरे प्रत्यावेदन पर सहानुभूतिपूर्वक विचार करने तथा समुचित आदेश हेतु माननीय न्यायालय के समक्ष प्रस्तुत करने की कृपा करें।

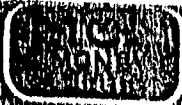

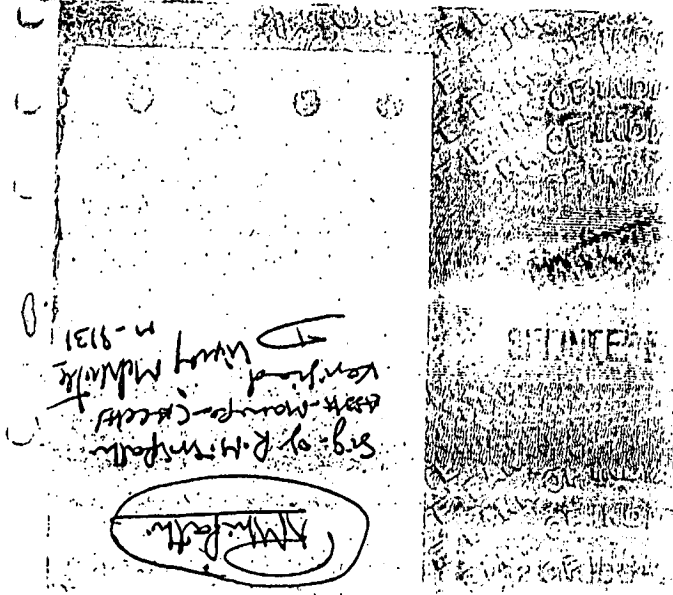
