Note-Property Statement -566

May kindly see the letters, placed below at flag 'A', & 'A-I' received from Sri Nitendra Kumar, Civil Judge (Sr. Div.), Sonbhadra regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Sri Nitendra Kumar had submitted his movable & immovable property statements for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 through his letters dated 15-09-2014 (flagged 'A'). Thereafter he was asked to furnish some information vide Court's letters dated 20-11-2014 & 03-02-2015 (flagged 'C' & 'C-I').

Now, Sri Nitendra Kumar has submitted required informations alongwith required through his letter dated 23-02-2015 (flagged 'A-I').

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

- (1) In the financial year 2010-11, the income from salary and other allowances is Rs.05,11,726/- and from this amount, Rs.29,393/- is deducted against NPS, Rs.1,440/- against GIS, Rs.32,436/- against LIC, Rs.86,000/- against Mutual fund, Rs.22,176/- against Income Tax, Rs.72,000/- against car loan, and Rs.74,000/- deposited in his PPF accounts in this years. The balance of his savings bank account (s) enhanced for Rs.10,190/- this year. As such, total deductions/ repayment is Rs.03,27,635/-. Thus, a sum of Rs.01,84,091/- was therefore available with him to meet out the household expenditure of his family consisting of three members in whole of the financial year 2010-11.
- (2) In the financial year 2011-12, the income from salary and other allowances is Rs.12,08,510/- and from this amount, Rs.2,21,272/- is deducted against NPS, Rs.3,960/- against GIS, Rs.32,436/- against LIC, Rs.86,000/- against Mutual fund, Rs.1,10,300/- against Income Tax,

Rs.72,000/- against car loan, and Rs.1,70,000/- deposited in his PPF accounts in this years. The balance of his savings bank account (s) enhanced for Rs.1,09,481/- this year. As such, total deductions/ repayment is Rs.08,05,449/-. Thus, a sum of Rs.04,03,061/- was therefore available with him to meet out the household expenditure of his family consisting of three members in whole of the financial year 2011-12.

- (3) In the financial year 2012-13, the income from salary and other allowances is Rs.07,80,526/- and from this amount, Rs.2,400/- is deducted against GIS, Rs.94,063/- against LIC, Rs.86,000/- against Mutual fund, Rs.53,193/- against Income Tax, Rs.20,000/- against Infrastructure bond, Rs.88,500/- against NSC and Rs.2,00,000/- deposited in his PPF accounts in this years. As such, total deductions/repayment is Rs.05,44,156/-. The balance of his saving bank account (s) is reduced to Rs.1,193/- from its previous year's balance. Thus, a sum of Rs.02,37,563/- was therefore available with him to meet out the household expenditure of his family consisting of three members in whole of the financial year 2012-13.
- (4) In the financial year 2013-14, the income from salary and other allowances is Rs.08,26,713/- and from this amount, Rs.76,641/- is deducted against NPS, Rs.2,400/- against GIS, Rs.94,063/- against LIC, Rs.70,475/- against Income Tax, Rs.28,000/- against NSC, and Rs.2,00,000/- deposited in his PPF accounts in this years. The balance of his savings bank account (s) enhanced for Rs.1,38,223/- this year. As such, total deductions/ repayment is Rs.06,09,802/-. He has also received a sum of Rs.7,750/- as interest from his saving bank accounts. Thus, a sum of Rs.02,24,611/- was therefore available with him to meet out the household expenditure of his family consisting of three members in whole of the financial year 2013-14.

In this connection it is submitted that Sri Nitendra Kumar has already submitted his property statement of the financial year 2009-10 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Shishir Kumar, the then Administrative Judge, Firozabad Judgeship at flag 'Z'.

It is further submitted that as as per policy/Court's Circular Letter, the officer has to submit his property statement for the years 2010-11 & 2011-12 in its next financial year i. e. in 2012-13 up to March 2013. He has submitted the

May, therefore, if approved, the property statements for the financial years 2010-11, 2011-12 2012-13 and 2013-14 alongwith letters dated 15-09-2014, and 23-02-2015 (flagged 'A', '& 'A-I') of Sri Nitendra Kumar, Civil Judge (Sr. Div.), Sonbhadra be laid before Hon'ble Mr. Justice Rakesh Srivastava, Administrative Judge, Sonbhadra Judgeship for his Lordship's kind perusal and orders?
