May kindly see the letter at flag 'A', received from Sri. Surjan Singh, Civil Judge (Jr. Div.), Banda regarding grant of permission to get transferred Maruti Alto car in his name from his wife's name.

In the letter, Sri. Surjan Singh has stated that before entering into judicial service at the time of his marriage, his wife gets a Maruti Alto car-bearing registration no. UP-32-BQ-8858 as gift from her father Sri. Harikaran Lal Verma and now the car have been regularly used by him in connection with performance of his judicial duties. He wants to get the car transferred in his name, so that he may get petrol allowance as per recommendation of Hon'ble Shetty Commission. His wife has consented to transfer the car in his name. He has also submitted a copy of registration certificate and consent letter of his wife against the proposed transfer, which are at flags 'B' & 'B-1'. He has, therefore, requested the Court to grant him permission to get the car transferred in his name from his wife's name.

In this connection, it is submitted that the officer had submitted his Property Statement, in which car has been shown (flag 'C'). It is further submitted that the relevant rule relating to transfer of movable property [Rule-24 (2) of U.P. Government Servant's conduct (Amendment) Rule-1998] runs as under: -

"A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority;

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

It is further submitted that as the officer has requested for grant of permission to get transferred the car in his name from his wife's name, he may be granted the permission, as requested, as per the rule referred to above, if the Court deemed fit and proper.

A. May, therefore, if approved by Hon'ble Mr. Justice V.M.Sahai, Sri. Surjan Singh, Civil Judge (Jr. Div.), Banda be granted permission to get transferred the Maruti Alto car-bearing registration no. UP-32-BQ-8858, in his name from his wife's name, as requested, with the direction that he may furnish copies of the relevant papers of transaction after its completion?
