May kindly see the letter dated 2.2.16 (at flag 'A') of Smt. Sneha Lata Singh, Civil Judge(Sr.Div.), Gorakhpur by which she has submitted the clarification about her salary and reasons for delay in submitting the aforesaid statement in connection with property statement for the financial years 2012-13 and 2013-14.

Earlier Smt. Singh has submitted her property statements for the financial years 2012-13 and 2013-14 vide her letter dated 16.11.15(flag 'B') in which she has not mentioned the mode of her salary whether it is her gross salary or net salary, hence a Court's letter dated 19.12.2015(flag 'C') has been sent to the officer in this regard.

In reply of aforesaid Court's letter, Officer has submitted the reply of aforesaid Court's letter vide her letter dated 2.2.16(flag 'A').

In this connection, it is submitted that as per statement of movable and immovable property statement for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by her are given below:-

(1) In the statement of movable and immovable property for the financial year 2012-13, Smt. Singh's Gross Income from salary is Rs.7,12,840/- from this amount, she has paid Rs.43,850/- against Income Tax, Rs.58,122/- against GPF, Rs.2400/- against GIS, Rs.40,000/- against PPF, Rs.1,50,000/- against FDRs, Rs.1,44,895/- against Insurances.. The balance of his Saving Bank Account(s) enhanced for Rs.33,651/- this financial year. As such, total deductions /Savings/investment is Rs.4,72,918/-. Thus a sum of Rs.2,39,922/- was therefore available with him to meet out the household expenditure of her family consisting of four members in the financial year 2012-13.

(2) In the statement of movable and immovable property for the financial year 2013-14, Smt. Singh's Gross Income from salary is Rs.8,03,471/- from this amount, she has paid Rs.60,990/- against Income Tax, Rs.69,625/- against GPF, Rs.4600/- against GIS, Rs.1,44,895/- against Insurances.. The balance of his Saving Bank Account(s) enhanced for Rs.2,25,594/- this financial year. As such, total deductions /Savings/investment is Rs.5,05,704/-. Thus a sum of Rs.2,97,767/- was therefore available with him to meet out the household expenditure of her family consisting of four members in the financial year 2013-14.

It is pertinent to mention here that husband of the officer Dr. V.P.Singh is Doctor whose annual income is Rs.11,00,000/-, son Prateek yearly income is Rs.3,50,000/- profession Advocate and another son Piyush annual income is Rs.3,00,000/- profession Tuition.

It is also to mention here that the officer has also submitted property statement for the financial year 2014-15 also but the same will be submitted for consideration when officer will submit the property statement for the financial year 2015-16 also, as per Court's Circular letter dated 13.5.04 and two years block policy.

The movable and immovable property statement for the financial year

2012-13 and 2013-14 has been submitted by the officer vide her letter dated 16.11.15(flag 'B') which was due to be submitted on or before 31.3.15. As such there is delay in submitting aforesaid property statement from the part of the officer for which the officer has stated that due to collection of her Bank accounts details belatedly, due to her transfer from one district to another district, the statements were not submitted in time for which officer has regretted.
