May kindly see the office note dated 20.2.16(flag 'N') regarding submission of statement of movable and immovable property for the financial year 2012-13 and 2013-14 of Smt. Sneh Lata Singh, the then Civil Judge(Sr,Div.), Gorakhpur presently Additional Chief Judicial Magistrate, Budaun which was submitted before Hon'ble Mr. Justice Ramesh Sinha, Administrative Judge, Gorakhpur for kind perusal and orders, on the perusal of the statement, His lordship has been pleased to order dated 31.3.16 as under:-

*"Officer concerned in her statement has not given details as to on which date and year, one kg. Gold, 500 gms. Silver, Wagon-R Car and revolver was acquired and what was the source of acquiring the same. She has further not disclosed model and other particulars of the revolver 0.32 and as to whether necessary permission and license with respect to same was obtained by her or not.*

*Officer concerned is directed provide complete and correct information about the same immediately.*

*Further officer concerned is directed to remain careful in future ensuring that the property statements is submitted within prescribed time."*

In compliance of the aforesaid Court's order, office has sent letter dated 16.4.2016 (at flag 'O' ) to the officer to comply the aforesaid court's order immediately

In reply of aforesaid Court's letter, officer has sent his reply vide his letter dated 18.6.16 at flags ( 'A-1') which is reproduced herein below in verbatim as under:-

1. एक किलो सोना, 500 ग्राम चाँदी मुझे बचपन से लेकर सेवा प्रारम्भ करने से पूर्व तक समय-समय पर ननिहाल, ददिहाल, मायके एवं ससुराल से प्राप्त हुआ था जिसके सम्बंध में मैंने न्यायिक सेवा में आने पर प्रथम प्रॉपर्टी स्टेटमेंट (डेट ऑफ ज्वाइनिंग) में अंकित कर रखा था।
2. वैंगन आर कार के सम्बंध में समस्त सूचना पत्र दिनांकित 15-01-08 द्वारा दी जा चुकी है।
3. रिवाइजर के सम्बंध में समस्त सूचना पत्र दिनांकित 04-07-12 तथा 07-11-12 द्वारा दी जा चुकी है।

आख्या प्रेषित करने में देरी का कारण मुझे पत्र दिनांक 30-04-16 को प्राप्त हुआ था। मेरा स्थानान्तरण माननीय उच्च न्यायालय के आदेशानुसार गोरखपुर से वदायूं हो गया था। दिनांक 07-05-16 को गोरखपुर से चार्ज छोड़ा। वदायूं में मकान में भरमत्त का कार्य पहले से चल रहा था। इस कारण गैस्ट हाउस में रहना पड़ा और मकान का कब्जा दिनांक 20-06-16 को मिलने के बाद ही आख्या भेजना सम्भव हो पाया जिसके लिए प्रार्थिनी क्षमा प्रार्थी है।
