May kindly see the letters dated 16.11.15 and 8.1.18 (flagged 'A' & 'A-1') by which Smt. Sneh Lata Singh, Secretary, D.L.S.A., Budaun has submitted her movable and immovable property statement for the financial years 2014-15, 2015-16 and 2016-17.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by her are given below.

(1) In the financial year 2014-15, of Smt. Singh's Income from Salary and other Sources is Rs.12,91,877/- (Rs.9,21,338/- from Salary, Rs.1,65,839/- from maturity of FDR and Rs.2,04,700/- from maturity of LIC) and from this amount, Rs.69,832/- against GPF, Rs.4800/- against GIS, Rs.40,000/- against PPF, Rs.69,595/- against Income Tax, Rs.1,24,703/- against Insurances. The balance of her Saving Bank Account(s) enhanced for Rs.2,84,825/- this year against the balance of previous year. As such, total deductions/repayment/Savings/investment is Rs.5,93,755/-. Thus a sum of Rs.6,98,122/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2014-15.

(2) In the financial year 2015-16, of Smt. Singh's Income from Salary and other Sources is Rs.20,52,493/- (Rs.10,99,367/- from Salary, Rs.8,18,005/- from closing of PPF and Rs.1,35,121/- from maturity of LIC) and from this amount, Rs.1,07,860/- against GPF, Rs.4800/- against GIS, Rs.1,00,000/- against PPF, Rs.82,995/- against Income Tax, Rs.1,21,500/- against Insurances. As such, total deductions/repayment/Savings/investment is Rs.4,17,155/-. The balance of her Saving Bank Account(s) decreased for Rs.3,86,239/- this year against the balance of previous year. Thus a sum of Rs.20,21,577/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2015-16.

And as per two years block policy, the property statement for the financial year 2016-17 will be taken up for consideration alongwith property statement for the financial year 2017-18, which will be submitted by the officer in near future, be due in the financial year 2018-19.

The movable and immovable property statement for the financial years 2014-15 and 2015-16 has been submitted by the officer vide her letters dated 16.11.15 and 8.1.18 (flagged 'A' & 'A-1') which was due to be submitted in third financial years 2016-17. As such there is delay in submitting the property statement for the financial year 2015-16 from the part of officer.

In this connection it is submitted Smt. Singh had already submitted her property statement upto financial year 2013-14 which had already been seen by Hon'ble Mr. Justice S.N.Shukla, the then Administrative Judge, Budaun Judgeship on 17.12.2014, which is at flag 'Z' and the said statement at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2014-15 and 2015-16, of Smt. Sneha Lata Singh, Secretary, D.L.S.A., Budaun may kindly be laid before Hon'ble Mrs. Justice Sunita Agarwal, Administrative Judge, Budaun Judgeship for Her Lordship's kind perusal and orders?
