May kindly see the letters dated 26.04.2012, 04.07.2012 & 07.11.2012, placed below at flags 'A', 'A-1' & 'A-2', by which Smt. Sneh Lata Singh, Civil Judge (Junior Division)/ Judicial Magistrate, Chandausi (Moradabad) has submitted information about purchase of a 32 bore Revolver.

In this connection it is submitted that earlier, Smt. Sneh Lata Singh through her letter dated 26.04.2012 (flag 'A') had furnished information about purchase of a 32 bore Revolver, regd. no. FG-35669 on 26.03.2012. on receipt of her letter, it was asked from her, vide Court's letter dated 21.05.2012 (flag 'X') to clarify as to why she has purchased the Revolver without prior permission of this Court, as per provisions of this Court's C.L. No. 11/ IVh-16/ Admin (A) dated 12.04.2010. She was also asked to furnish complete and pointwise information about purchase of the said Revolver as per Court's C.L. no. 25/ Admin (A) dated 13.07.1998.

In reply of Court's letter dated 21.05.2012, Smt. Sneh Lata Singh, through her letter dated 04.07.2012 (flag 'A-1') has submitted pointwise information about the purchase, as per Court's C.L. no. 25/ Admin (A) dated 13.07.1998, by simply saying that if any rule has been breached by her in connection with the purchase of Revolver, she is regretting for the same.

The pointwise information, as submitted by her, is as below:-

On receipt of the above mentioned information, vide Court's letter dated 06.08.2012

(flag 'X-1'), it was again asked from the officer to give specific reasons for not obtaining prior permission to purchase the Revolver, as well as her gross and take home salary both.

Now, in reply of Court's letter dated 06.08.2012, Smt. Sneh Lata Singh has submitted through her letter dated 07.11.2012 (flag 'A-2') that she has applied for firearm's licence on 23.01.2010 i.e. since long before issuance of Court's C.L. in the matter. At present her gross and take home salary is Rs. 52,949/- and Rs. 46,449/- respectively.

In this connection, it is submitted that relevant Court's C.L. no. 11/ IVh- 16/ Admin (A) dated 12.04.2010 (flag 'D') provides that all the judicial officers be directed that application to obtain necessary permission for purchase of firearm be made in the Court at the time of submission of application for grant of such licence. In the instant case, the officer had applied for issuance of licence before issuance of Court's C.L. no. 11/ IVh- 16/ Admin (A) dated 12.04.2010. It appears that the officer interpreted the Court's Circular letter dated 12.04.2010 in such a way that as she applied a licence earlier on 23.01.2010, she is not required to obtain permission to purchase the Revolver. But, the contents of Court's Circular letter dated 12.04.2010 should not be taken in such spirit. However, she has regretted for any mistake done in this regard.

Under the facts and circumstances, mentioned above, if approved, the information/ file of the officer may kindly be laid before Hon'ble Mr. Justice Sanjay Misra for His Lordship's kind perusal, information under Rule 24(2) of U.P. Government Servant's Conduct Rules 1956 and further orders, as deem fit by His Lordship?
