May kindly see the letter, placed below at flag 'A' & 'A-1', received from Sri Santosh Kumar Yadav, Judicial Magistrate, Sitapur regarding submission of statement of movable & property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2006-07 & 2007-08, 2008-09 & 2009-10 in the prescribed Proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Sri Santosh Kumar Yadav had submitted his consolidate movable property statement for the financial year 2006-07 & 2007-08 & 2008-09 through his letter dated 30-09-2010 (flagged 'A-1') but he had not submitted ^{his} his movable & immovable property statement of financial year 2009-10 and had also not given the balance amount in his savings A/C no. 01190109349 of S. B. I., Faizabad in the end of the every financial year i. e. 31-03... in column no 5 and details information of gross income taken from salary per annum and details of deduction i. e. GPF, GIS, HRA, IT and other investment in column no 5 & 8 in the property statement of the financial year 2006-07, 2007-08 & 2008-09 of the proforma. Thereafter he was asked to send his movable and immovable property statement of the financial year 2009-10 and also send the aforesaid information of the property statement of the financial year 2006-07, 2007-08 & 2008-09 vide court's letter dated 28-01-2011 (flagged 'C').

Now in reply of Court's letter dated 28-01-11 Sri Yadav has sent letter dated 11-04-2011 (flagged 'A'), by which he has submitted the immovable & immovable property statement of the financial years 2009-10 and also given the balance of his savings accounts and details of income and deduction of the the financial year 2006-07, 2007-08 & 2008-09 reply of the Court's letter lated 20-04-2011, which is at flag 'A'.

In this connection it is further submitted that Sri Yadav had already submitted the statement at the time of entering into Judicial Service which has already been seen by Hon'ble Mr. Justice Sanjay Misra, the then Administrative Judge Faizabad Judgeship on 08-07-2008 submitted through office note dated 08-07-2008 at flag 'B'. He has not given any reason for delay.

May, therefore, if approved, the statement for the financial years 2006-07 & 2007-08, 2008-09 & 2009-10 of Sri Santosh Kumar Yadav, Judicial Magistrate, Sitapur, ^{be} laid before Hon'ble Mr. Justice S. S. Chauhan, Administrative Judge, Sitapur Judgeship for his Lordship's kind perusal and orders?


