May kindly see the letter, placed below at flag 'A' received from Sri Santosh Kumar Yadav, Chief Judicial Magistrate, Pratapgarh regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2010-11, the income from salary and arrears is Rs.06,04,658/-, and from this amount, Rs.1,440/- is deducted against GIS, Rs.67,565/- against CPF, Rs.27,934/- against IT, Rs.47,470/- against LIC, Rs.20,000/- against Infrastructure bond, Rs.94,401/- against personal loan and Rs.05,000/- deposited in his PPF account. As such, total deductions/ repayment/ savings/ investment is Rs.02,63,810/-. The balance of his savings bank account (s) reduced for Rs.4,764/- (including interest) from its previous year's balance. Thus, a sum of Rs.3,45,612/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial years 2010-11.

However, it is pertinent to mention here that his wife Smt. Sandeepa Yadav is working as Civil Judge (Sr. Div.), Pratapgarh and her income is Rs.5,94,111/- per annum.

(2) In the financial year 2011-12, the income from salary and arrears is Rs.11,39,982/-, and from this amount, Rs.1,440/- is deducted against GIS, Rs.1,00,000/- against CPF, Rs.1,26,000/- against IT, Rs.47,470/- against LIC, Rs.20,000/- against Infrastructure bond, Rs.1,25,868/- against personal loan and Rs.05,000/- deposited in his PPF account. The balance of his savings bank account (s) enhanced for Rs.47,341/- (including interest) from its previous year's balance. As such, total

deductions/ repayment/ savings/ investment is Rs.04,73,119/-. Thus, a sum of Rs.06,66,863/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial years 2011-12.

His wife's income is Rs.12,64,801/- per annum.

(3) In the financial year 2012-13, he income from salary and arrears is Rs.8,63,151/-, and from this amount, Rs.2,600/- is deducted against GIS, Rs.05,559/- against CPF, Rs.49,802/- against IT, Rs.47,470/- against LIC, and Rs.60,000/- deposited in his PPF account. The balance of his savings bank account (s) enhanced for Rs.12,082/- (including interest) from its previous year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.01,77,513/-. He has also received a sum of Rs.60,000/- from the LIC as money back policy. Thus, a sum of Rs.07,45,683/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial years 2012-13.

His wife's income is Rs.07,24,205/- per annum.

(4) In the financial year 2013-14, the income from salary and arrears is Rs.08,44,492/-, and from this amount, Rs.2,800/- is deducted against GIS, Rs.1,10,080/- against CPF, Rs.62,228/- against IT, Rs.80,798/- against LIC, and Rs.1,50,580/- deposited in his PPF account. As such, total deductions/ repayment/ savings/ investment is Rs.04,06,486/-. The balance of his savings bank account (s) reduced for Rs.2,143/- (including interest) from its previous year's balance. Thus, a sum of Rs.4,40,149/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial years 2013-14.

His wife's income is Rs.07,74,204/- per annum.

In this connection it is submitted that Sri Santosh Kumar Yadav, has already submitted her property statement of the financial year 2009-10 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice S.S. Chauhan the then Administrative Judge, Sitapur at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the years 2010-11 & 2011-12 in its next financial year i. e. in 2012-13 up to March 2013. He has submitted the same

through letter dated 22-01-2016 as such, there is delay in submitting the said statements and his property statement for the years 2012-13 & 2013-14 in its next financial year i. e. in 2014-15 up to March 2015. He has submitted the same through letter dated 22-01-2016 and as such, there is delay in submitting the said statements. He has stated in his letter dated 22-01-2016 (flagged 'A') that due to rush of Judicial work he could not the submitted the same within due time.

May, therefore, if approved, the property statements for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 alongwith letter dated 22-01-2016 (flagged 'A') of Sri Santosh Kumar Yadav, Chief Judicial Magistrate, Pratapgarh be laid before Hon'ble Mr. Justice Shabihul Hasnain, Administrative Judge, Pratapgarh judgeship for His Lordship's kind perusal and orders?
