May kindly see the letter dated 4.3.17 (at flag 'A') by which Sri Santosh Kumar Yadav, Civil Judge(Sr.Div.), Pratapgarh has submitted his property statement for the financial years 2014-15 and 2015-16.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the financial year 2014-15, Sri Yadav's Total income from Salary is Rs.9,58,087/- from this amount he has paid Rs.4800/- against GIS, Rs.52,942/- against C.P.F., Rs.80,798/- against LIC, Rs.1,10,000/- against PPF, Rs.73,076/- against Income Tax. The balance of his Saving Bank Account(s) enhanced for Rs.1,05,414/- this year against the balance of previous year. As such, total deductions /Savings/investment is Rs.4,27,030/-. Thus a sum of Rs.5,31,057/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2014-15.

(2) In the financial year 2015-16, Sri Yadav's Total income from Salary is Rs.12,98,489/- from this amount he has paid Rs.5600/- against GIS, Rs.1,93,511/- against C.P.F., Rs.80,798/- against LIC, Rs.1,20,000/- against PPF, Rs.1,41,002/- against Income Tax and Rs.1,50,000/- against Sukanya Samridhi Yagna. The balance of his Saving Bank Account(s) enhanced for Rs.2,748/- this year against the balance of previous year. As such, total deductions /Savings/investment is Rs.6,93,659/-. Thus a sum of Rs.6,04,830/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2015-16.

It is pertinent to mention here that the wife of the officer Smt. Sandeepa Yadav is also A.C.J.M. In same Judgeship whose annual income is Rs.11,77,858/-(in the financial year 2014-15) and Rs.11,45,281/-(in the financial year 2015-16)

The movable and immovable property statement for the financial years 2014-15 and 2015-16 has been submitted by the officer vide his letter dated 4.3.17 (flagged 'A') which was due to be submitted in third financial year 2016-17 i.e. on or before 31.3.17. As such there is no delay in submitting the aforesaid Property statement from the part of officer.

In this connection, it is submitted that Sri Yadav had already submitted his property statement upto 2013-14 which was seen by Hon'ble Mr. Justice Shabihul Hasnain, Administrative Judge, Pratapgarh Judgeship on 23.2.16 at flag 'Z' and the said statement at flag 'M'.
