Again a Court letter dated 2.6.11 (at flag 'E') was sent to the Officer to send complete information as asked for in the Court dated 4.2.11.

In reply of the aforesaid Court's letter, Officer has sent his revised property statement for the financial year 2006-07, 2007-08, 2008-09 and 2009-10 vide his letter dated 25.6.11(at flag 'A').

In this connection it is submitted that Sri Kumar has joined the U.P.Judicial Service on 16.6.06.

If approved, the statement of movable and immovable properties submitted by Sri Mohan Kumar, Civil Judge(Jr.Div.), Jalaun at Orai at the time entering into Judicial Service and for the financial year 2006-07, 2007-08, 2008-09 and 2009-10 may be laid before Hon'ble Mr. Justice Dilip Gupta, Administrative Judge, Jalaun at Orai Judgship for His Lordship's kind perusal and orders ?
