May kindly see the letter, placed below at flag 'A' & 'A-1', received from Sri Gyanendra Singh-II, Civil Judge (Jr. Div.), Ambedkarnagar regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial year 2008-09 & 2009-10 in the prescribed Proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection it is submitted that earlier Sri Gyanendra Singh-II the then Additional Civil Judge (Jr. Div.), Chandauli Moradabad had submitted the movable & immovable property statement for financial year 2008-09 & 2009-10 through the District Judge endorsement no.2153/10 dated 03-09-2010 (flagged 'A-1') but as per report dated 27-02-2012 of S. O. Admin (H) (flagged 'D') the same has not received in the office of the Court. Thereafter, the District Judge, Moradabad was asked vide Court's letter dated 24-03-2012 (flagged 'C') to intimate as to whether Sri Gyandendra Singh had submitted the letter dated 03-09-2010 in your office, and if yes kindly to very dispatch of the same. In reply of the Court's letter the District judge, Moradabad has informed through his letter dated 06-04-2012 (flagged 'A') that Sri Gyanendra Singh-II the then Additional Civil Judge (Jr. Div.), Chandauli Moradabad now posted in AmbedkarNagar Judgeship has submitted the property statement and the same send to Hon'ble High Court on 03-09-2010.

In this connection it is further submitted that Sri Gyanendra Singh-II had submitted the property statement of the financial year 2008-09 & 2009-10 to the District Judge, Moradabad and District Judge, Moradabad has also sent through endorsed no. 2153/ 10 dated 03-09-2010 to Hon'ble High Court (flagged 'A') but as
