May kindly see the letter, placed below at flag 'A' received from Sri Gyanenendra Singh-II, Additional Chief Judicial Magistrate, Ghaziabad, regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2012-13 and 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

- (1) In the financial year 2012-13, the income from salary is Rs.08,59,387/-, and from this amount, Rs.71,766/- is deducted against CPF, Rs.2,400/- against GIS and Rs.43,474/- against Income Tax, Rs.86,178/- against LIC, Rs.35,400/- against PLI, Rs.60,000/- against SIP, Rs.84,000/- against house loan and Rs.70,000/- deposited in his PPF account in this financial year. As such, total deductions/repayment is Rs.4,53,218/-. The balance of his saving bank account (s) is reduced to Rs.2,49,158/- from its previous year's balance. Thus, a sum of Rs.06,55,327/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial years 2012-13.
- (2) In the financial year 2013-14,the income from salary is Rs.08,92,652/-, and from this amount, Rs.75,811/- is deducted against CPF, Rs.3,000/- against GIS and Rs.73,276/- against Income Tax, Rs.86,178/- against LIC, Rs.60,000/- against SIP, Rs.1,20,000/- against house loan. The balance of his savings bank account (s) enhanced for Rs.04,13,187/- this year. As such, total deductions/repayment is Rs.08,31,452/-. He has also received a sum of Rs.60,000/- from the money back LIC policies, Rs.23,178/- from Income tax refund, Rs.1,26,052/- from S.A., Medical and other allowance, Rs.76,922/- as honorarium and Rs. 43,439/- as interest from his PPF and S/B accounts.

Thus, a sum of Rs.03,90,791/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial years 2013-14.

In this connection it is submitted that Sri Gyanenendra Singh-II, has already submitted his property statement of the financial year 2011-12 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice A. P. Sahi, Administrative Judge, Ghaziabad Judgeship at flag 'Z'.

It is further submitted that as as per policy/Court's Circular Letter, the officer has to submit his property statement for the years 2012-13 & 2013-14 in its next financial year i. e. in 2014-15 up to March 2015. He has submitted the same through his letter dated 20-02-2015 and as such, there is no delay in submitting the same statements for the years 2012-13 and 2013-14.

May, therefore, if approved, the property statements for the financial years 2012-13 and 2013-14 alongwith letter dated 20-02-15 (flagged 'A') of Sri Gyanenendra Singh-II, Additional Chief Judicial Magistrate, Ghaziabad be laid before Hon'ble Mr. Justice A. P. Sahi, Administrative Judge, Ghaziabad Judgeship for his Lordship's kind perusal and orders?
