May kindly see the letters dated 17.10.2016 and 9.2.2017 (flagged 'A' and 'A-1') by which Sri Gayendra Singh-II, Additional Chief Judicial Magistrate(N.R.), Ghaziabad has submitted his movable and immovable property statement for the financial years 2014-15 and 2015-16.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below.

(1) In the financial year 2014-15, of Sri Singh's total income from Salary and other Sources is Rs.10,96,261/- (Rs.10,52,708/- from gross salary including arrears of pay & allowances and Rs.43,553/- from interest from Salary and PPF A/c) from this amount Rs.87,789/- deducted against Income Tax, Rs.82,794/- against CPF, Rs.4800/- against GIS, Rs.1,50,000/- against PPF, Rs.86,178/- against LIC, Rs.60,000/- against SIP, Rs.1,20,000/- towards loan. As such, total deductions/repayment/Savings/investment is Rs.5,91,561/-. The balance of his Saving Bank Account(s) decreased for Rs.60,078/- this year against the balance of previous year. Thus a sum of Rs.5,64,778/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2014-15.

(2) In the financial year 2015-16, of Sri Singh's total income from Salary and other Sources is Rs.15,59,240/- (Rs.14,70,333/- from gross salary including arrears of pay, Encashment of earned leave & allowances, Rs.24,094/- from maturity of NSC and Rs.64,813/- from interest from Salary and PPF A/c) from this amount Rs.1,80,983/- deducted against Income Tax, Rs.1,07,714/- against CPF, Rs.4800/- against GIS, Rs.1,50,000/- against PPF, Rs.86,178/- against LIC, Rs.60,000/- against SIP, Rs.1,20,000/- towards loan. The balance of his Saving Bank Account(s) enhanced for Rs.5,77,913/- this year against the balance of previous year. As such, total deductions/repayment/Savings/investment is Rs.12,87,588/-. Thus a sum of Rs.2,71,652/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2015-16.

The movable and immovable property statement for the financial years 2014-15 and 2015-16 has been submitted by the . . . 2

officer firstly vide his letter dated 17.10.2016 (flagged 'A') which was due to be submitted in third financial years 2016-17. As such there is no delay in submitting the Property statement from the part of officer.

In this connection it is submitted last time Sri Singh had already submitted his property statement upto financial year 2013-14 which had already been seen by Hon'ble Mr. Justice A.P.Sahi, the then Administrative Judge, Ghaziabad Judgeship on 23.4.15, which is at flag 'Z' and the said statement at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2014-15 and 2015-16 of Sri Gaynendra Singh-II, Additional Chief Judicial Magistrate(N.R.), Ghaziabad may kindly be laid before Hon'ble Mr. Justice Shabihul Hasnain, Administrative Judge, Ghaziabad Judgeship for His Lordship's kind perusal and orders?
