May kindly see the letters dated 5.3.19 (flag 'A';)) received from Sri Gyanendra Singh-II, Special Chief Judicial Magistrate, Kanpur-Nagar regarding submission of statements of movable and immovable properties acquired/held by him or by any member of his family for the financial years 2016-17 and 2017-18 and in prescribed proforma to this Court for kind perusal and information as required by the Court's circular letter No.16/IV-h-16/Admin.(A), dated 13.5.2004.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

- In the financial year 2016-17, Sri Singh's Total Income from Salary and other Sources is Rs.13,60,892/- (Rs.12,92,697/- from Salary and Rs.68,195/- from interest:) and total deductions /Savings /investment is Rs.9,34,031/-. Thus a sum of Rs.6,37,615/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2016-17.
- In the financial year 2017-18, Sri Singh's Total Income from Salary and other Sources is Rs.14,27,238/- (Rs.13,40,882/- from Salary and Rs.86,356/- from Archivet) and total deductions /Savings /investment is Rs.10,98,423/-. Thus a sum of Rs.3,28,815/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2017-18.

In this connection, it is submitted that Sri Singh has already submitted his property statement upto financial year 2015-16 which has been seen by Hon'ble Mr. Justice Shabihul Hasnain, Administrative Judge, Ghaziabad Judgeship at flag 'Z' and said statement is at flag 'M.

The movable and immovable property statement for the financial years 2016-17 & 2017-18 has been submitted by the officer vide his letter dated 5.3.19 (flag 'A') which was due to be submitted in third financial year 2018-19 i.e. on or before 31.3.2019. As such there is no delay in submission of the aforesaid Property statement from the part of the officer.
