With reference to your endorsement no.2386/10 dated 12.10.2010, on the above subject I am directed to return herewith original bill/vouchers and other relevant papers (containing 41 leaves) in respect of medical reimbursement claim of Sri Gyanendra Singh-II, Additional Civil Judge (Jr. Div.), Moradabad with the following objections:-

1. Affidavit to the effect that Smt. Akanksha Singh wife of Sri Gyanendra Singh-II, Additional Civil Judge (Jr. Div.), Moradabad, aged about----years in whose respect the reimbursement of medical charges is claimed is residing with him and she is wholly dependent upon him at the time of treatment. She is not engaged in any Govt./ non Govt. service/ Business/Profession. She has no other sources of income as well is to be submitted.
2. Reference slip of Government hospital by which Smt. Akanksha Singh was referred to the Saroj Nursing Home, Lucknow, is to be submitted.
3. The ex-post-facto permission of Chief Medical Officer/ Superintendent of concerned District may be submitted in respect of the treatment of Smt. Akanksha Singh, as required in the Govt. Order no.427/पाच-6-2004-294/96, टी०सी० dated 18.02.2005.
4. The calculation memo should be verified and sanction-able amount is mentioned by the Chief Medical Officer/ Superintendent of concerned District and payable and non-payable amount is to be mentioned in the column meant for the purpose.
5. The medical reimbursement, amounting to Rs.20,594.00 may be sanctioned to Sri Gyanendra Singh-II by the District Judge, Moradabad, after completing all the formalities under the provisions contained in the Govt Order 1209/V-6-2004-294/96, T.C., dated 09.08.2004 as such the papers may be retained by the District Judge, Moradabad for taking necessary action.

6. In the medical reimbursement claim, amounting to Rs.60,307.00 the bill no.00750/10-11 dated 29.04.2010 is for Rs.800.00 whereas amount has been mentioned in the calculation memo for Rs.1000.00 which is to be rectified.
7. Period of treatment taken as out door patient i.e. 01.09.2009 to 04.05.2010 and as indoor patient i.e. 29.04.2010 to 04.05.2010 (during hospitalization) are overlapping to each other. Each claim should be preferred separately.

I am therefore request you kindly direct to Sri Gyanendra Singh-II to submit the medical reimbursement claim for Rs.60,307.00 alongwith relevant bill/vouchers and relevant papers after removing the objections mentioned in the body of the note at point no.1 to 7 and medical reimbursement claim, amounting to Rs.20,594.00 of Sri Gyanendra Singh-II, it may be sanctioned by him after completing all the formalities in terms of Govt. Order 1209/V-6-2004-294/96, T.C., dated 09.08.2004.
