May kindly see the letter, placed below at flag 'A', 'A-1' & 'A-II', received from Sri Anirudha Maurya, Additional Session Judge, Gonda regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2004-05, 2005-06, 2006-07 & 2007-08, 2008-09 & 2009-10 in the prescribed Proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Sri Maurya had submitted his movable property statement for the financial years 2005-06, 2006-07 & 2007-08 through his letter dated 19-04-2008 (flagged 'A-II') but he has not submitted the movable & immovable property statement of the financial year 2004-05. Thereafter he was asked to send his movable & immovable property statement for the financial year 2004-05 vide court's letter dated 22-05-2008 (flagged 'C'). Thereafter he has submitted his movable & immovable property statement of the financial year 2008-09 & 2009-10 through his letter dated 03-09-10 (flagged 'A-I') but not replied the Court's letter dated 22-05-08. Thereafter he had again sent a Court's reminder letters dated 26-11-10 & 15-03-11.

In reply of Court's letter dated 15-03-11 Sri Maurya has sent letter dated 23-03-2011 (flagged 'A'), by which he has submitted the movable & immovable property statement of the financial year 2004-05 and regretted for the same.

In this connection it is further submitted that Sri Maurya had already submitted the statement of his property acquired/ held up to the calendar Year 2003 which has already been seen by Hon'ble Mr. Justice N. K. Mehrotra, the then Administrative Judge Bulandshahar Judgeship on 01-04-2004, submitted through office note dated 03-02-2004 at flag 'B'.

May, therefore, if approved, the statement for the financial years 2004-05, 2005-06, 2006-07 & 2007-08, 2008-09 & 2009-10 of Sri Anirudha Maurya, Additional Session Judge, Gonda laid before Hon'ble Mr. Justice Shabihul Hasnain, Administrative Judge, Gonda Judgeship for his Lordship's kind perusal and orders?
