May kindly see the letter dated 17.6.14 (at flag 'A') of Sri Anirudh Maurya, Additional District and Sessions Judge, Saharanpur by which he has submitted his PPF and LIC amount deposited in the financial years 2012-13 and 2013-14 regarding his property statements for the financial years 2012-13 and 2013-14.

Earlier Sri Maurya has submitted his aforesaid property statement vide his letter dated 5.4.14(flag 'B') in which his LIC and PPF amount was not correct then a letter dated 7.6.14(flag 'C') has been sent to the officer in this regard,

In reply of aforesaid Court's letter, Officer has submitted his details of PPF and LIC vide his letter dated 17.6.14(flag 'A').

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the financial year 2012-13, Sri Maurya's Gross income from salary is Rs.16,53,371/-, from this amount, he has paid Rs.1,34,304/- against GPF, Rs.4800/- against GIS, Rs.1,46,620/- against Income Tax, Rs.60,000/- against PPF, Rs.2,28,778/- against LIC. The balance of his Saving Bank Account(s) enhanced for Rs.1,80,876/-. As such, total deductions /Savings/investment is Rs.7,55,378/- this year. Thus a sum of Rs.8,97,993/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2012-13.

(2) In the financial year 2013-14, Sri Maurya's Gross income from salary is Rs.15,43,593/-, from this amount, he has paid Rs.1,32,590/- against GPF, Rs.4800/- against GIS, Rs.1,74,500/- against Income Tax, Rs.1,00,000/- against PPF, Rs.2,25,577/- against LIC. The balance of his Saving Bank Account(s) enhanced for Rs.3,91,863/-. As such, total deductions /Savings/investment is Rs.10,29,330/- this year. Thus a sum of Rs.5,14,263/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2013-14.

The movable and immovable property statement for the financial years 2012-13 and 2013-14 has been submitted by the officer vide his letter dated 17.6.14(flag 'A') which was due to be submitted in the financial year 2014-15 i.e. on or before 31.3.15. As such there is no delay in submitting the aforesaid Property statement from the part of the officer.

In this connection, it is submitted that Sri Maurya has already submitted his property statement upto 2011-12 which was seen by Hon'ble Mr. Justice Amar Saran, Administrative Judge, Saharanpur at flag 'Z' and the

said statement is at flag 'M'.
