May kindly peruse the application in Form 425-A (at flag 'A') of Sri Aniruddha Maurya, Retired Principal Judge, Family Court, Bhadohi at Gyanpur for making payment of 90% amount of the balance, available in his G.P. Fund Account No.L.J.U.-21131. Sri Aniruddha Maurya retired from the post of Principal Judge, Family Court, Bhadohi at Gyanpur after attaining the age of superannuation on 30.06.2016.

Through letter bearing endorsement No.705/II Gyanpur dated 27.06.2016 (at flag 'B') the District Judge, Bhadohi at Gyapur has submitted original Pass-Book of G.P.Fund Account No.L.J.U.-21131 (at flag 'C') of Sri Aniruddha Maurya along with three sets of application in Form 425-A under the signature and seal of District Judge, Bhadohi at Gyanpur as well as Senior Treasury Officer, Bhadohi at Gyanpur (at flag 'D') together with three sets of calculation sheets from the financial year 2011-2012 to 2016-2017 (at flags 'E', 'F', 'G', 'H', 'I' and 'J') and Reconciliation Certificate, issued by the office of the A.G.(A.&E.)-II, U.P., Allahabad on 03.12.2015 (at flag 'K'). The District Judge, Bhadohi at Gyanpur has requested the Court, for making payment of 90% amount of G.P. Fund of Sri Maurya from his G.P. Fund Account No.L.J.U.-21131.

As per Reconciliation Certificate issued from the office of Accountant General, (A.&E.)-II, U.P., Allahabad a total of Rs.23,85,369/- is available as closing balance of F.Y.2013-2014 in G.P.F.Account No.L.J.U.-21131 whereas G.P.F. pass-book closing balance for F.Y. 2013-2014 is Rs.24,00,967/-. Further, from perusal of G.P.F. pass-book and calculation sheets of the F.Y. 2014-2015, 2015-2016 and 2016-2017, it is evident that the following amount was credited in respective manner :

Going further, it is submitted that out of the total amount of Rs.34,55,931/-stands to his credit in his G.P.Fund account, the District Judge, Bhadohi at Gyanpur in the capacity of D.D.O. of the Judgeship as well as the Senior Treasury Officer, Bhadohi at Gyanpur in capacity of Checking Accounts Authority has recommended for sanction of Rs.31,10,338/-only in favour of Sri Aniruddha Maurya as 90% amount of his G.P.Fund.

In this context it is submitted that the payment of 90% of G.P.Fund amount of Retiring/Retired Judicial Officer is to be sanctioned by this Court in terms of G.O.No.Sa-4-A.G.-57/X-84-510-84, dated 26.12.1984 and General Provident Fund (Uttar Pradesh) (Second Amendment) Rules, 2000 on submission of Reconciliation Certificate, issued by the office of the A.G.(A.&E.)-II, U.P., Allahabad, G.P.Fund Pass-Book of Retiring/Retired Judicial Officer prepared at least from the financial year 1985-86 up to the month of his retirement and calculation sheets of his G.P.Fund of the current financial year (up to the month of retirement) as well as five preceding financial years to this Court by the Drawing and Disbursing Officer of concerned Establishment/Judgeship with his recommendation and recommendation of the Chief/Senior Treasury Officer of the District, for payment of 90% of G.P.Fund amount to the Retiring/Retired Judicial Officer.

After perusal of G.P. Fund Pass-Book of Sri Aniruddha Maurya, it appears that Final Withdrawal is nil and one Temporary Advance i.e. first of Rs.25,000/-was sanctioned to him by the concerned Judgeship in the financial year 2001-2002 respectively and the same has been shown debited from his G.P. Fund Account No. L.J.U.-21131.

In view of the facts, mentioned above, if approved by the Learned Registrar (Judicial) (Budget), the file may be laid before Hon'ble Mr. Justice Manoj Misra, for His Lordship's kind perusal and order to the effect that a sum of Rs. 31,10,338/- (Rs.Thirty One Lacs Ten Thousand Three Hundred & Thirty Eight) only may be sanctioned to Sri Aniruddha Maurya, Retired Principal Judge, Family Court, Bhadohi at Gyanpur as 90% amount of the total balance available in his G.P. Fund Account No.L.J.U.-21131, up till the date of his retirement from service i.e. 30.06.2016, subject to the condition that in case of over payment, if any, reported later on, by office of the Accountant General (A.&E.)-II, U.P., Allahabad, he shall refund the excess payment along with amount of interest accrued thereon in lump sum within a month?

His Lordship may also be requested kindly to sign the draft sanction order, placed below, at the place cross marked with red pen?
