Subject: Payment of three T.A bills of Sri Chandra Mohan Chaturvedi, the then Additional Civil Judge(JD), Kasia-Kushinagar now posted as Civil Judge(JD), Ballia.

Sir,

With reference to aforesaid subject, I am sending herewith three T.A bills, in original, of Sri Chandra Mohan Chaturvedi and to say that following objections have been found in said T.A bills :

**T.A bill amounting Rs. 3,027/- & Rs. 8,479/-**

- (1) Send copies of all those letters vide which request for allocation of budget was made.
- (2) Send copy of order/notification vide which Sri Chandra Mohan Chaturvedi was asked to attend respective training sessions.
- (3) The following three certificates are to be written by you(DJ, Kushinagar) on the T.A bill itself, under your own signature and seal :
  - (a) That the claim is genuine, admissible and is in order.
  - (b) That it is being claimed for the first time and has not been drawn before.
  - (c) That necessary entries have been made in office records, in such a way that double drawn would not be possible.

**Transfer T.A bill amounting Rs. 11,186/-**

- (1) Intimate the date when the said bill was submitted before concerned treasury office for the first time.
- (2) Adequate and cogent reason for not submitting the said bill before concerned treasury office within stipulated time-period of one year from the date of its becoming due.
- (3) Send copy of transfer order vide which Sri Chandra Mohan Chaturvedi had travelled from Gonda to Padrauna.
- (4) Since only 1<sup>st</sup> class railway fare is admissible to judicial officers on transfer related journeys performed by them therefore a new bill is required to be prepared with expenditure modified as per 1<sup>st</sup> class railway fare. Along with new modified bill, a certificate issued by Railway authority, showing distance from Gonda to Padrauna and fare as per 1<sup>st</sup> class railway ticket, is also to be submitted.
- (5) Truck no. by which house-hold goods were transported is to be mentioned on the T.A. Bill.
- (6) The details of family members with their age requires to be mentioned on the T.A bill, duly certified by Sri Chandra Mohan Chaturvedi that they are fully dependent upon him.
- (7) The following three certificates are to be mentioned by you on the T.A bill itself, under your own signature and seal :
  - a. That the claim is genuine, admissible and is in order.
  - b. That it is being claimed for the first time and has not been drawn before.
  - c. That necessary entries have been made in the office records in such a
