May kindly see the letter dated 20.05.2013 of District Judge, Saharanpur regarding medical reimbursement claim of Sri Aniruddha Maurya, Additional District & Sessions Judge (Ex- Cadre), Saharanpur, amounting to Rs.1,29,993.00, incurred in the treatment of Carcinoma gall bladder with infiltration of colon of his wife Smt. Anita Maurya for the period from 01.11.2012 to 14.11.2012 at Max Hospital, New Delhi placed at Flag 'A'.

It may be recalled that Sri Aniruddha Maurya has earlier submitted the aforesaid claim, amounting to Rs.1,31,093.00 through the letter dated 03.01.2013 of the District Judge, Saharanpur placed at Flag 'B' in which the District Judge has stated that Sri Aniruddha Maurya has submitted medical reimbursement claim, amounting to Rs.1,92,147.00 but the Chief Medical Officer, Saharanpur has verified the claim for Rs.1,31,093.00 but office of the Court has found following objections:-

1. Sri Aniruddha Maurya has not submitted medical reimbursement claim in prescribed profoma in **appendix-'C'**.
2. Sri Aniruddha Maurya has submitted two medical reimbursement claim amounting to Rs.1100.00 and Rs.1,29,993.00 in two separate essentiality certificates. The claim Rs.1100.00 is required to be separated and submitted to the District Judge, Saharanpur for necessary action as the claim is less than Rs.1,00,000.00.
3. The calculation memo should be prepared separately of each claim and payable and non-payable amount is to be mentioned in the column meant for the purpose. The sanction-able amount is also mentioned by the C.M.O..

Due to aforesaid objections the claim was returned to the District Judge, Saharanpur through Court's letter dated 15.04.2013 placed at Flag 'C'. Now Sri Aniruddha Maurya has re-submitted the claim, after removing the objections, through the letter dated 20.05.2013 of the District Judge, Saharanpur (**Flagged 'A'**).

Through the aforesaid letter Sri Maurya has submitted Appendix 'C' regarding dependency of his wife, Essentiality Certificate and Calculation Memo duly countersigned by the Chief Medical Officer, Saharanpur in which the sanction-able amount is mentioned for Rs.1,29,993.00. Sri Maurya has also submitted original bill/vouchers and other relevant papers duly countersigned by the treating Doctor.

In this connection it may be submitted that under the provisions contained in Government Order no.2275/V-6-11-1082-87, dated 20.09.2011 the sanctioning authority for Government servant who are in service, placed below:-

Above Rs.5,00,000.00 After recommendation from Medical and Health Department and prior approval of the Finance Department, Administrative Department in the Government.

In the instant case the medical reimbursement claim is amounting for Rs.1,29,993.00 and according to Government Order no.2275/V-6-11-1082-87, dated 20.09.2011 the medical reimbursement claim for more than Rs.1,00,000.00 but upto Rs.2,50,000.00 is to be sanctioned by the Head of the Department and as such it may be placed before Hon'ble Mr. Justice Devendra Pratap Singh for orders.

If approved by Hon'ble Mr. Justice Devendra Pratap Singh the medical reimbursement claim, amounting to Rs.1,29,993.00 may be sanctioned to Sri Aniruddha Maurya, Additional District & Sessions Judge (Ex- Cadre), Saharanpur, incurred in the treatment of Carcinoma gall bladder with infiltration of colon of his wife Smt. Anita Maurya for the period from 01.11.2012 to 14.11.2012 at Max Hospital, New Delhi and His Lordship may also be requested to sign the draft order placed at Flag 'X'?
