May kindly see the letter dated 03.01.2013 of District Judge, Saharanpur regarding medical reimbursement claim of Sri Aniruddha Maurya, Additional District & Sessions Judge (Ex- Cadre), Saharanpur, amounting to Rs.1,31,093.00, incurred in the treatment of Carcinoma gall bladder with infiltration of colon of his wife Smt. Anita Maurya for the period on 2010.2012 and from 01.11.2012 to 14.11.2012 at Max Hospital, New Delhi placed at Flag 'A'.

Through the aforesaid letter the District Judge has forwarded the medical reimbursement claim papers and stated that Sri Aniruddha Maurya has submitted medical reimbursement claim, amounting to Rs.1,92,147.00 but the Chief Medical Officer, Saharanpur has verified the claim for Rs.1,31,093.00. The District Judge has requested this Court to sanction the said amount as medical claim.

In this connection it may be submitted the aforesaid claim has been checked by the office and found following discrepancies:-

1. Sri Aniruddha Maurya has not submitted medical reimbursement claim in prescribed profoma in **appendix-'C'**.
2. Sri Aniruddha Maurya has submitted two medical reimbursement claim amounting to Rs.1100.00 and Rs.1,29,993.00 in two separate essentiality certificates. The claim Rs.1100.00 is required to be separated and submitted to the District Judge, Saharanpur for necessary action as the claim is less than Rs.1,00,000.00.
3. The calculation memo should be prepared separately of each claim and payable and non-payable amount is to be mentioned in the column meant for the purpose. The sanction-able amount is also mentioned by the C.M.O..

If approved by the Learned Registrar General the medical reimbursement claims, amounting to Rs.1100.00 and Rs.1,29,993.00 of Sri Aniruddha Maurya, Additional District & Sessions Judge (Ex- Cadre), Saharanpur may be return^{ed} to the District Judge, Saharanpur with the request to take necessary action in the medical reimbursement claim, amounting to Rs.1100.00 and ask Sri Aniruddha Maurya to re-submit the claim amounting to Rs.1,29,993.00 to this Court after removing the above mentioned objections?
