In view of order dated 30.04.2014 (placed at Flag 'A') of In-charge Registrar (Budget) in the matter of medical reimbursement claim, amounting to Rs.1,29,993.00 of Sri Apiruddha Maurya, Additional District & Sessions Judge (Ex- Cadre), Saharanpur, incurred in the treatment of Carcinoma gall bladder with infiltration of colon of his wife Smt. Anita Maurya for the period from 01.11.2012 to 14.11.2012 at Max Hospital, New Delhi. The above mentioned order of In-charge Registrar (Budget) is runs as under:-

"Put up with fresh note as per new Rules-2014"

It may be recalled that earlier the aforesaid medical reimbursement claim was uealt under the provision contained in Medical Attendance Rules-2011 bearing notification no.2275/V-6-11-1082-87, dated 20.09.2011 but now "The Uttar Pradesh Government Servants (Medical Attendance) (First Amendment) Rules, 2014 bearing notification No.474/V-6-14-1082/87 T.C., dated 4th March 2014 have been implemented and as such now medical reimbursement claims is required to be dealt under the provisions contained in "The Uttar Pradesh Government Servants (Medical Attendance) (First Amendment) Rules, 2014 read with Medical Attendance Rules-2011.

In this connection it may be submitted that under the provisions conta—I—Government bearing notification No.474/V-6-14-1082/87 T.C., dated 4th March 2014 substituted some provisions of Medical Attendant Rule-2011 bearing notification no.2275/V-0-11-1083-87, dated 20.09.2011 the sanctioning authority for Government servant who are in service or retired placed below:-

the ajoresaid medical reimbursement claim, amounting to Rs.1,29,993.00 of Sri Aniruddha Maurya, Additional District & Sessions Judge (Ex- Cadre), Saharanpur may be sanctioned by the District Judge, Saharanpur in the capacity of Head of the Office as the claim is less than Rs.2,00,000.00.

If approved by the Registrar (Budget) the medical reimbursement claim (original bill/vouchers and other relevant papers) of Sri Aniruddha Maurya may be returned to District Judge, Saharanpur alongwith the copy of "The Uttar Pradesh Government § 1 (Medical Attendance) (First Amendment) Rules, 2014" bearing Notification no.474/V-v-1+1082/87 T.C., dated 4th March 2014, with the request to take necessary action at his end under the provisions contained in "The Uttar Pradesh Government Servants (Medical Attendance) (First Amendment) Rules, 2014" Notification no.474/V-6-14-1082/87 T.C., dated 4th March 2014 substituted the Medical Attendant Rule-2011 notification no.2275/V-6-11-1082-87, dated 20.09.2011 as the claim is less than Rs.2,00,000.00?
