May kindly see the letters, placed below at flag 'A', received from Sri Abhai Prakash Narain, Additional Civil Judge (Sr. Div.)/ A.C.M.M., Kanpur Nagar regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2009-10, 2010-11, 2011-12 & 2012-13 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial year 2009-10, 2010-11, 2011-12 & 2012-13 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2010-11, the total income from salary is Rs.04,79,626/- and from this amount, Rs.1440/- is deducted against GIS, Rs.18,628/- against Income Tax, Rs.67,797 against LIC, Rs.60,000/- against RLI, Rs.20,000/- against Rec bond and Rs.5,000/- deposited in his PPF account in this year. As such, total deductions/repayment is Rs.01,72,865/-. The balance of his savings bank account (s) reduced for Rs.13,053/- this year. He has also received Rs.1,40,000/- as agricultural income. Thus, a sum of Rs.4,59,814/- was therefore available with him to meet out the expenditure of his family consisting of three members in whole of the financial year.

(2) In the financial year 2011-12, the total income from salary and arrears is Rs.10,23,274/- and from this amount, Rs.2000/- is deducted against GIS, Rs.61,034/- against NPS, Rs.1,26,670/- against Income Tax, Rs.67,797/- against LIC, Rs.77,032/- against car loan, Rs.20,000/- against IDFC bond, Rs.20,000/- against RLI bond and Rs.10,000/- deposited in his PPF account in this year. As such, total deductions/repayment is Rs.03,84,534/- The balance of his savings bank account (s) reduced for Rs.21,698/- this year. He has also received Rs.1,40,000/- as agricultural income. Thus, a sum of Rs.8,05,439/- was therefore available with him to meet out the expenditure of his family consisting of three members in whole of the financial year.

(3) In the financial year 2012-13, the total income from salary and arrears is Rs.06,63,981/- and from this amount, Rs.2400/- is deducted against GIS, Rs.35,757/- against NPS, Rs.43,473/- against Income Tax, Rs.67,797/- against LIC, Rs.3,30,517/- against car loan, and Rs.20,000/- deposited in his PPF account in this year. The balance of his savings bank account (s) enhanced for Rs.21,481/- this year. As such, total deductions/repayment is Rs.05,21,425/- He has also received Rs.1,45,000/- as agricultural income Thus, a sum of Rs.4,26,030/- was therefore available with him to meet out the expenditure of his family consisting of four members in whole of the financial year.

(4) In the financial year 2013-14, the total income from salary and arrears is Rs.06,97,937/- and from this amount, Rs.2400/- is deducted against GIS, Rs.81,289/- against NPS, Rs.49,369/- against Income Tax, Rs.92,493/- against LIC, and Rs.50,000/- deposited in his PPF account in this year. The balance of his savings bank account (s) enhanced for Rs.18,06,276/- this year. He has also deposited Rs.35,00,000/- in her wife's account. As such, total deductions/repayment is Rs.55,81,287/- He has also received Rs.60,000/- as agricultural income and Rs.56,68,000/- received to sell his parental immovable property. Thus, a sum of Rs.8,44,110/- was therefore available with him to meet out the expenditure of his family consisting of four members in whole of the financial year.

In this connection it is submitted that last time, Sri Abhai Prakash Narain had submitted his property statement at the time of entering into Judicial service (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Sabhajeet Yadav, the then Administrative Judge, Ghazipur at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the years 2009-10 & 2010-11 in its next financial year i. e. in 2011-12 up to March 2012. He has submitted the same through his letters dated 15-03-2016 as such, there is delay in submitting the same statements. The property statement for the years 2011-12 & 2012-13 in its next financial year i. e. in 2013-14 up to March 2014. He has submitted the same through his letter dated 15-03-2016 and as such, there is delay in submitting the

same statements for the years 2011-12 and 2012-13. He has not submitted the the same within due time due to some family problem (as stated in his letter dated 15-03-2016 at flag 'A') for which he has regretted.
