May kindly see the letter, placed below at flag '1' received from Sri Abhay Prakash Narain, Additional Chief Metropolitan Magistrate, Kanpur Nagar regarding grant of permission to purchase firearm (Revolver).

In his letter, Sri Narain has stated that he had applied for firearm's licence to the District Magistrate, Kanpur Nagar, (copy of application is at flag 'A'). He has proposed to purchase the said firearm from Small Arms Factory, Kanpur, ^{expenditure of} which will be borne from his S.B. A/c no. 11189163015 (Copy of passbook is at flag 'B'). He has therefore, requested that his application may kindly be placed before the Hon'ble Court for grant of permission to purchase a Revolver.

In this connection, it is submitted that by this Court C.L. no. 11/ IVh-16/ Admin (A) dated 12.04.2010 (copy at flag '3'), **all the judicial officers are directed that application to obtain necessary permission for purchase of firearm be made in the Court at the time of submission of application for grant of such licence.** The estimated cost of the firearm (Revolver) proposed to be purchased by the officer is around Rs. 87,000/-. According to the C.L. the officer is required to take permission of this Court to purchase firearm, for which he has requested. His case may be considered favourably subject to the condition that he will submit full details of the transaction immediately after purchase of firearm.

Under the facts and circumstances, if approved, the file may be laid before Hon'ble Mr. Justice Sanjay Misra for His Lordship's kind perusal ~~and orders~~ and if His Lordship approves, Sri Abhay Prakash Narain, Additional Chief Metropolitan Magistrate, Kanpur Nagar may be granted permission to purchase Revolver from Small Arms Factory, Kanpur, estimated cost of which is Rs. 87,000/-, subject to the condition that relevant papers of the transaction be furnished by him immediately after its purchase?
