In compliance of court's letter dated 26.3.09, Smt Nirmala, Judicial Magistrate Hardoi through her letter dated 26.5.09 has submitted a certificate from her husband's department to the effect that her husband is not getting personal pay under Voluntary family planning programme. The details of the claim are as under

- 1- Her date of birth is 25-9-1966
- 2- Her present age is 42 years 4 months
- 3- She joined the U.P. Judicial Service on 16-6-2006
- 4- She has only one child vide declaration at page 'B'
- 5- The age of her child is 13 years 5 months and his date of birth is 20-8-1995 vide birth certificate issued by Fatima Hospital, Lucknow. Attached photo copy of certificate is at page 'D'.
- 6- She has not got the personal pay under Voluntary family planning programme vide declaration at page 'C'
- 7- Her husband is alive. He is a government servant and he is not getting said benefit vide declaration at page 'B'. Smt. Nirmala has also furnished a certificate of her husband's department to this effect. Photocopy of certificate is at page 'X'
- 8- Neither any departmental enquiry is pending against Smt. Nirmala Judicial Magistrate, Hardoi nor she has been punished by stoppage of increment and she has not been suspended in such departmental enquiry as reported by S.O. Confidential OA which is at page 'E'

In terms of G.O. NO. Pa. Ka 1683/16-11-80-9/155/79 dated 26-5-1980 and G.O. NO. Pa. Ka. 2667/16-11-80-9/155/79 dated 11-6-1980 required declarations have been furnished by her and same are at page 'B' and 'C'




