May kindly see the letter dated 11.07.2011, placed below at flag 'A', received from Smt. Sangita Kumari, Additional Civil Judge (Junior Division), Pratapgarh, by which she has requested the Court to issue 'No-Objection Certificate'/'Identity Certificate' for obtaining Passport.

In her letter, Smt. Sangita Kumari has stated that :-

1. She wish to apply for a passport for which an Identity certificate (No Objection Certificate) from the Hon'ble Court is required as per direction in column 20 of the application issued by the Ministry of External Affairs.
2. There is no possibility of arising any embarrassing position either for the Government of India or the Government of U.P. due to her visit to any foreign country.
3. She has never applied for no objection certificate for the same before this, therefore no request of her refused for issue of a No Objection Certificate for obtaining a passport.
4. She has never visited a foreign country earlier.
5. No departmental proceeding has been initiated or pending against her.
6. She has two children (Km Riya aged 12 years and Master Archit aged 10 years) dependent on her.
7. She is sending three passport size photographs of herself.

She has, therefore, requested that her request may kindly be placed before Hon'ble High Court for a No Objection Certificate.

In this connection, it is submitted that 'No-objection Certificate' for obtaining a Passport may be issued to the officers in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'B'). It is further submitted that as per reports, placed below, no vigilance/departmental enquiry is pending against Smt. Sangita Kumari. Now, as per orders of the Court, 'No-objection Certificates' are being issued to judicial officers for obtaining Passport.

May, therefore, if approved by Hon'ble Mr. Justice Devi Prasad Singh, Administrative Judge, Pratapgarh Judgeship, the 'No Objection Certificate' at flag 'C' be issued, in favour of Smt. Sangita Kumari, Additional Civil Judge (Junior Division), Pratapgarh, for obtaining Passport with the direction that she should take prior permission of the Court before proceeding abroad?
