

May Kindly see the letter, placed below at flag 'A', received from Smt. Sangeeta Kumari, Civil Judge (Junior Division), Pratapgarh regarding grant of permission to appear in 1st year examination of LL.M. course via correspondence from Kurukshetra University, Kurukshetra, Haryana, scheduled to be held in May-June 2010.

Smt. Sangeeta Kumari in her letter has stated that she has taken admission in two year's LL.M. course via correspondence from Kurukshetra University, Kurukshetra, Haryana in the year 2009-10. She has also submitted a copy of the admission card and has informed that the proposed date for the 1st year examination is May-June 2010. She has, therefore, requested that she may kindly be allowed to appear in the above mentioned 1st year examination (Session 2009-2010).

In this connection, it is submitted that earlier the officer had informed vide her letter dated 21.11.2009 (flag 'B') that she is willing to pursue LL.M. course from Kurukshetra University and had requested to grant her 'No-Objection Certificate'. On asking about the LL.M. course, whether it is a regular or correspondence one, she has now informed that the course is through correspondence and has requested for grant of permission to appear in the above mentioned 1st year examination (Session 2009-2010) of LL.M. It is further submitted that the officer has joined the U.P. Nyayik Sewa in the year 2006. She may be granted the permission, as requested, if the Court so desires. It is further submitted that a judicial officer can be accorded permission to attend academic classes and specialized higher studies in terms of G.O.No. 24/1066-Appointment (B) dated 21.08.1967 (copy at flag X), subject to the following conditions: -

- (1) Government work should not suffer in any way.
- (2) The academic classes are held outside office hours.
- (3) No preferential treatment will be given in the matter of leave, postings and transfer.
- (4) The permission can be withdrawn without notice if; it is found at any time that the government servant neglects her normal work or that public work suffers, in any way.

May, therefore, if approved by Hon'ble The Acting Chief Justice, permission be accorded to Smt. Sangeeta Kumari, Civil Judge (Junior Division), Pratapgarh to
