May kindly see the letters, placed below at flag 'A' & 'A-1', received from Sri Sanjay Kumar, Additioanl Civil Judge (Jr. Div.), Muzaffarnagar regarding grant of permission to appear in examination for the post of Deputy J.A.G./ Dy. Commandant in Indo Tibetan Border Police Force.

In his earlier letter dated 26.06.2013 at flag 'A', Sri Sanjay Kumar has stated that he is applying for the post of Deputy J.A.G./ Dy. Commandant in Indo Tibetan Border Police Force, for which he needs N. O. C. from Hon'ble High Court. He has, therefore, requested to the Court that N. O. C. may kindly be issued in his favour so that he may be able to sit in test for the aforesaid post. On receipt of his letter, a letter dated 23.07.2013 ^(Happened) was sent to the District Judge, Muzaffarnagar asking the officer to intimate the particular as to how he is eligible to apply for the post of Deputy J.A.G./ Dy. Commandant in Indo Tibetan Border Police Force and also inform, the scheduled date of pre/main examination and interview, if fixed in the mean time and to submit declaration that by appearing in the aforesaid pre/main examination and interview Judicial work will not suffer in any way.

Now, in reply of the Court's letter dated 23.07.2013, Sri Sanjay Kumar, in letter dated 31.07.2013 (flag 'A-1') stated that eligibility conditions for applying for aforesaid post is that candidate must have degree in law, five years experience in legal affairs and should be qualified for enrolment as an advocate and maximum age fixed for this post 35 years which is relaxable as per rules. He has further stated that he possess all the essential qualifications and fulfill all the eligibility conditions required for the above post. Ministry of Home Affairs/I. T. B. P. F. HQ has not yet notified the dates of examination and interview. Generally tests are conducted on holidays and if He appear in this test his Judicial work shall not suffer.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 19-06-2006. It is desirable that he may be accorded permission to appear in written examination for the post of Deputy J.A.G./ Dy. Commandant in Indo Tibetan Border Police Force at present, if the Court so desires. Issuance of 'No Objection Certificate/ permission to appear in Interview will be considered at later stage, when need arises on qualifying the written examination for grant of permission to appear in written examination. However, acceptance of his request for grant of permission to appear in written at this stage on the discretion of the Court. Permission to appear in such type of written examination may be accorded, but subject to the following conditions: -

- (1) Government work should not suffer in any way.

(3) The permission can be withdrawn without notice, if it is found at any time that the government servant neglect his normal work or that public work suffers, in any way.
