May kindly see the letter, placed at flag 'A', received from Sri Manoj Kumar, Civil Judge (Junior Division), Shahjahanpur regarding issuance of 'No Objection Certificate' for obtaining Passport.

In his letter at flag 'A', Sri Manoj Kumar has stated that in near future, he wants to go on Kailash Mansarover Yatra at his own expenses. For the purpose of obtaining passport, he needs 'No Objection Certificate' from the Hon'ble Court. He has also submitted the following required information/ declaration for issuance of 'No Objection Certificate' for obtaining Passport :-

- 1 From his foreign journey, there will be no embarrassment in position before the Government of India or the Government of U.P.
- 2 Prior to this application for issuing 'No Objection Certificate' no such application was ever sent by him, nor any such application has been rejected by the Hon'ble Court.
- 3 He has not visited any foreign country earlier.

He has, therefore, requested that the Hon'ble Court may kindly be moved to issue him 'No Objection Certificate' for obtaining a Passport to visit Kailash Mansarover.

In this connection, it is submitted that 'No Objection Certificate' for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'B'). As per reports, placed below, no vigilance/ departmental enquiry is pending against Sri Manoj Kumar. Now, as per orders of the Court, 'No-objection Certificates' are being issued to judicial officers for obtaining Passport.

Under the facts and circumstances, mentioned above, if approved by Hon'ble Mr. Justice Ashwani Kumar Singh, Administrative Judge, Shahjahanpur, the 'No Objection Certificate' at flag 'C' be issued, in favour of Sri Manoj Kumar, Civil Judge (Junior Division), Shahjahanpur, for obtaining Passport, with the direction that he should take prior permission of the Court before proceeding abroad?
