May kindly see the letter, placed below at flag '2A', received from Sri Manoj Kumar, Judicial Magistrate, Allahabad, by which he has requested the Court for issuance of 'Identity Certificate' as per Annexure 'B' of Passport booklet, for obtaining Passport.

By his letter, Sri Manoj Kumar has submitted his 'Affidavit', photographs and details of his dependent family members for issuance of 'Identity Certificate' as per Annexure 'B' of Passport booklet, for obtaining Passport.

In this connection, it is submitted that Sri Manoj Kumar, through his letter dated 08.02.2013 (flag '1A') has submitted that he had earlier applied for 'No Objection Certificate' on 02.03.2012 for obtaining Passport from Shahjahanpur Judgeship, but no communication has been made with him in this regard. He has, therefore, requested, for issuance of 'No Objection Certificate' for obtaining Passport. On receipt of his said letter, the file has been checked and it is found that a 'No Objection Certificate' dated 10.07.2012 (office copy is at flag 'C') on his request as per then practice, had already been issued as per approval of Hon'ble Administrative Judge, Shahjahanpur (Order is at flag 'D'). Accordingly, a Court's letter dated 20.02.2013 has been sent to the District Judge, Shahjahanpur with a request to verify its receipt and to return the original 'No Objection Certificate' dated 10.07.2012, which was sent earlier through Court's letter no. 10326/ IV- 3446/ Admin (A) dated 16.07.2012 (flag 'E'). The District Judge, Shahjahanpur, in reply of Court's letter dated 20.02.2013, has informed that the Court's letter dated 16.07.2012 as well as 'No Objection Certificate' dated 10.07.2012 had not been received in his office.

In such event of misplacement of earlier issued 'No Objection Certificate' dated 10.07.2012 and as per new policy of the Court about issuance of 'Identity Certificate' on new proforma, in place of old 'No Objection Certificate', the officer through Court's letter dated 13.03.2013 (flag 'F') has been asked to submit details of his dependents, required 'Affidavit' as per Section 6 (2) of Passport Cat, 1967 and his photographs, so that he may be issued 'Identity Certificate' as per Annexure 'B' of Passport booklet, for obtaining Passport, which has been submitted by the officer through his letter dated 21.03.2013 now (flag '2A'). The 'Affidavit' is at flag '2B'. He has therefore, requested the Hon'ble High Court for issuance of 'Identity Certificate' on proforma of Annexure 'B' for obtaining Passport.

In is further submitted that now, 'Identity Certificate' on proforma of 'Annexure 'B' is started to be issued for obtaining passport in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'G'). It is also submitted that as per reports, placed below, no vigilance/departmental enquiry is pending against Sri Manoj Kumar. His request may be considered.

May, therefore, if approved by Hon'ble ^{Mr} Justice S.P. Mehrotra, Administrative Judge, Allahabad Judgeship, 'Identity Certificate' at flag '2C' be now issued, in duplicate,
