May kindly see below placed transfer notification of Hon'ble Mr. Justice Vinod Prasad from Hon'ble High Court, Allahabad to the Orissa High Court with the direction to assume charge of his office over there on or before 02.07.2014.

In this context it is submitted that till date of transfer Hon'ble Mr. Justice Vinod Prasad was as Controlling Officer taking care of all work relevant with sanction of TA bills of retired Judicial Officers, pre-audit sanction of time-barred TA bills as well as arrears of pay-bills of Judicial Officers of U.P. Judicial Services (Copy of nomination letter placed at flag 'X') as he was nominated by this Court for said purpose.

Since Hon'ble Mr. Justice Vinod Prasad has now been transferred to the Orissa High Court, a fresh nomination is required to be done for said purpose.

Sir,

With reference to your letter No. 54/IX dated 09.01.14, on the above subject, I am returning herewith D.A Arrears bill(in original) of Smt. Renu Singh, Civil Judge(JD), Farrukhabad and to inform you that according to G.O No. A-1-2925/X-3/1(6)-65 dated 18.9.85 read with G.O No. A-1-3959/X-3/1(6)-65 dated 23.1.86, following objections have been found in aforesaid bill :

- (1) Adequate and cogent reason, as required under Rule 141 of F.H.B Volume V Part-I, for not preferring aforesaid bill within stipulated time-line i.e one year from the date of its becoming due, has not been stated.
- (2) The following three certificates are to be recorded by you(District Judge, Farrukhabad), on the bill itself under your own signature and seal :-
 - (a) That the claim is genuine, admissible and is in order.
 - (b) That it is being claimed for the first time and has not been drawn before.
 - (c) That necessary entries have been made in office records, in such a way that double drawn would not be possible.

I, therefore, request you to kindly get aforementioned objections removed and thereafter resubmit the aforesaid bill along with requisite information/documents to this Court at the earliest possible so that further necessary action may be taken in the matter.
