May kindly see letter dated 24.03.2014(at flag 'Z') of the District Judge, Farrukhabad regarding pre-audit of DA arrears claim of Smt. Renu Singh, Civil Judge(JD), Farrukhabad amounting Rs.14,119/- for the period from 01.01.2011 till 14.09.2011.

Vide aforesaid letter the District Judge, Farrukhabad has informed that the instant claim is of the time when Smt. Renu Singh was posted in Sitapur Judgeship and the period of the instant claim involves several nature of leaves availed by Smt. Renu Singh, the duration of which was not clear initially. Later, when status of duration of leaves availed by Smt. Renu Singh became clear, claim was prepared and submitted before concerned treasury for necessary action but by that time claim had gone time-barred thus objection of instant claim being time-barred was recorded on the bill.

Smt. Renu Singh has also provided due and drawn statement on separate page, affixed on 2nd & 3rd page of claim, showing report of how much amount has already been drawn by her and how much is yet to be paid.

The District Judge, Farrukhabad, in accordance with G.O. No. A-1-3959/X-3/1(6)-65 dated 23.01.1986 has also provided the following three certificates on the bill itself, under his own signature and seal(at flag 'A').

- (1) That the claim is genuine, admissible and is in order.
- (2) That it is being claimed for the first time and has not been drawn before.
- (3) That necessary entries have been made in the office records in such a way that double drawn would not be possible.

In this context it is submitted that on the basis of above three certificates of the District Judge, Farrukhabad, the pre-audit sanction of aforesaid arrears bill can be accorded in terms of G.O No. A-1-2925/X-3/1(6)65 dated 18.09.85(at flag 'B') read with G.O. No. A-1-3959/X-3/1(6)-65 dated 23.01.1986(at flag 'C').

Further, it is pertinent to mention here that earlier, instant matter was put up before Hon'ble Mr. Justice Vinod Prasad for His Lordship's kind perusal and order vide office note dated 18.04.14(at flag 'D') but owing to Lordship's transfer from Hon'ble High Court, Allahabad to Orissa High Court, file was sent back to office without order. Presently, vide order dated 12.09.14(at flag 'E') of Hon'ble the Chief Justice, High Court, Allahabad, Hon'ble Mr. Justice Vikram
