May kindly see the application/ letter dated 03.05.2011 at flag 'A', received from Sri Shailender Singh, Civil Judge (Junior Division)/ Judicial Magistrate, Mau (Chitrakoot), by which he has requested the Court for issuance of 'No Objection Certificate' for obtaining Passport.

In his letter Sri Singh has stated that he want to apply for a passport and for that he requires a 'No Objection Certificate', so that he can apply for passport. He has also submitted that:-

1. There is no possibility of arising embarrassing position before the Government of India or U.P. from his foreign visit.
2. No such request for issue of No Objection Certificate for obtaining a passport or permission to visit abroad was ever refused to him.
3. He has not visited any foreign country earlier.

He has therefore, requested that his request may be considered.

In this connection, it is submitted that 'No-objection Certificate' for obtaining a Passport may be issued to the officers in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'B'). It is further submitted that as per reports, placed below, no vigilance/ departmental enquiry is pending against Sri Singh. Now, as per orders of the Court, 'No-objection Certificates' are being issued to judicial officers for obtaining Passport.

May, therefore, if approved by Hon'ble Mr. Justice S.C. Agarwal, Administrative Judge, Chitrakoot Judgeship, the 'No Objection Certificate' at flag 'C' be issued, in favour of Sri Shailender Singh, Civil Judge (Junior Division)/ Judicial Magistrate, Mau (Chitrakoot), for obtaining Passport with the direction that he should take prior permission of the Court before proceeding abroad?
