May kindly see the letters, placed below at flag 'A' and 'A-1' received from Sri Shailender Singh, Civil Judge(Jr.Div.), Chitrakoot for grant of permission to do M.A. Political Science(Private) from C.C.S. University, Meerut.

In his earlier letter at flag 'A', Sri Singh has stated that he passed B.A. Honors Political Science and has selected in P.C.S.(J), U.P. He has got keen interest in higher studies and he sought to do M.A. Political Science (Private) from C.C.S., University Meerut as there is no classes as continuing M.A. Political Science(Private). He had also stated that his higher study of M.A. Political Science(Private) will not hamper his Judicial work in any way. He had requested to consider his request so that he may take admission in 2010 -11 Session. On receipt of his said application, his file was scrutinized and it was found that in the year 2009, he had been granted permission to do LL.M.(correspondence Course) from Kurukshetra University, Kurukshetra (Haryana), as per his request, vide order dated 12.1.09(flag 'B') of Hon'ble the Chief Justice and thus he has been asked vide Court's letter dated 22.10.10 (at flag 'C') to intimate as to whether he has completed the said LL.M. Course.

Now in reply of Court letter dated 22.10.10, Sri Singh has informed that as per the eligibility criteria by the Kurushetra university, Kurukshrestra, Haryana. He was not eligible to get the admission in LL.M. Course, so he failed to got the admission in LL.M. Of Kurushetra university, Kurukshrestra, Haryana.

Now in the circumstance his request for grant of permission to study of M.A. Political Science(Private) from C.C.S. University, Meerut is to be considered as the officer is not persuing LL.M. Course. Acceptance of his request for taking admission in the course of M.A. Political Science (Private) may be considered as there appears to be no necessity to join any classes, but it is on the discretion of the Court. It is also submitted that a Judicial Officer can be accorded permission to attend academic classes and specialized higher studies in terms of G.O.No.24/1066-Appointment (B) dated 21.08.1967(copy at flag X), subject to the following conditions:-

- (1) Government work should not suffer in any way.
- (2) The academic classes are held outside office hours.
- (3) No preferential treatment will be given in the matter of leave, postings and transfer.
- (4) The permission can be withdrawn without notice if; it is found at any time that the government servant neglects his normal work or that public work suffers, in any way.

A' Under the circumstances, if approved by Hon'ble the Chief Justice, Sri Shailender Singh, Civil Judge(Jr.Div.), Chitrakoot may be accorded permission to take admission and to pursue the course of M.A. Political Science(Private) from C.C.S. University, Meerut from upcoming Session, as requested, subject to the conditions mentioned above?
