May kindly see the letter, placed below at flag 'A' & 'A-I', received from Sri Shailendra Singh, Judicial Magistrate, Mirzapur regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2006-07 & 2007-08, 2008-09 & 2009-10 in the prescribed Proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Sri Singh had submitted his movable property statement for the financial years 2006-07, 2007-08, 2008-09 and 2009-10 through his letter dated 19-01-2012 (flagged 'A-I'). Thereafter he was asked to clarify that he he had get total income Rs.2,66,977/- in the financial years 2008-09 and from this amount Rs.17,927/- was deducted as GIS+ income tax + exempt etc. And from this amount he has deposited of Rs. 44921/- (included interest) in his SB A/C no. 30058445394 in SBI, Meerut, Rs, 30,647/- (included interest) in PPF A/C no 30556585222 SBI, Rs. 38,632/- deposited annual premium of LIC Policy and Rs. 77,904/- paid the car loan taken by him. The income expenditures savings & investments appears to be disproportionate vide court's letter dated 21-03-2012 (flagged 'C').

In reply of Court's letter dated 21-03-12 Sri Singh has sent letter dated 20-07-2012 (flagged 'A'), which is in verbatim-

माननीय महोदय,

उपरोक्त वर्णित विषय के बावत् ससम्मान निवेदन है कि माननीय उच्च न्यायालय के पत्रांक द्वारा मुझसे यह स्पष्ट करने को कहा गया है कि इन्कम टैक्स व पीपी0एफ0 की किश्त, एल0आई0सी0 की किश्त तथा कार लोन अदा करने के उपरान्त वेतन से किस प्रकार अपने परिवार का गुजारा कर रहा हूँ।

महोदय उपरोक्त के सम्बन्ध में यह निवेदन करना है कि मेरे परिवार में मैं मेरी पत्नी तथा लगभग 1 वर्ष की बेटी है। मैं मधुमेह रोग से पीड़ित हूँ, मेरी पत्नी व मेरी बेटी अपने दादा-दादी के पास दिल्ली में रहते हैं।

दिन-प्रतिदिन व्यय के बावत् मैं यह उल्लिखित करना चाहता हूँ कि सेवा लाभ के रूप में मकान का कोई किराया देय नहीं है, टेलीफोन तथा मोबाईल का बिल विभाग द्वारा ही देय है, तथा विद्युत बिल 500-500/- रूपया विभाग द्वारा ही देय होता है, समाचार-पत्र व मासिक पत्रिका विभाग द्वारा दिया जाता है, तथा 75 ली. पेट्रोल विभाग द्वारा दिया जाता है। घर पर कोई नौकर अलग से नहीं रखा गया है। मेरा विवाह लगभग 10 वर्ष पूर्व हुआ है। तथा सभी सामान व कपड़े पर्याप्त मात्रा में मौजूद हैं।

मधुमेह रोग से पीड़ित होने के कारण मेरा खान-पान पर बहुत ज्यादा खर्च नहीं है। तथा वर्ष 2008-09 पर्यन्त वस्तु भस्ती थी। सेवा में पेन्शन के सम्बन्धित कोई व्यवस्था नहीं है। मधुमेह से पीड़ित होने के कारण भविष्य के लिए बचत भी करता हूँ। इस तरह इन्कम टैक्स, एल0आई0सी0, पीपी0एफ0 व कार लोन के पश्चात् मेरे पैसा बचता है, जो मैं मेरा व मेरे परिवार का गुजारा, मेरे स्तर के अनुसार हो जाता है। मेरे माता, भाई, बहन की जिम्मेदारी मेरे उपर नहीं है।

अतः स्पष्टीकरण माननीय महोदय की सेवा में सादर प्रेषित है।


Seen the report of District Judge dated 22/24.9.2008 and perused the record.




