May kindly see the letter, placed below at flag 'A', received from Sri Munna Prasad, Civil Judge (Junior Division), Jalaun for grant of permission to reside at Orai (district headquarter) and to attend the outlying Court daily at Jalaun after performing journey from Orai every working day i.e. to leave the place of posting every day, which has been duly forwarded by the District Judge, Jalaun at Orai through his letter at flag 'Z'.

In his letter at flag 'A', Sri Munna Prasad has stated that he has been posted as Civil Judge (Jr. Div.) in the outlying Court at Jalaun and he has joined there on 08.06.2009. He has further stated that at Jalaun there is no official residence, the place is a small and undeveloped town and there is no possibility to arrange private residence. Moreover, no medical facility is there. The distance of Jalaun town from the district headquarter Orai is 20 Kms. only and therefore, he is willing to attend the outlying Court daily at Jalaun after performing journey from Orai every day. He will perform journey from his personal vehicle, his judicial work will not be affected due to this and he will not claim any traveling allowance for the same. He has therefore, requested the Court to accord him permission to attend the outlying Court daily at Jalaun after performing journey from district headquarter Orai every working day with his personal vehicle. The District Judge, Jalaun at Orai has recommended for his request through his letter at flag 'Z'.

In this connection, it is submitted that In the instant case, the officer is requesting to reside at district headquarter Orai and to attend the outlying Court daily at Jalaun after performing journey from Orai every working day i.e. to leave the place of posting every day on the grounds, mentioned above. Acceptance of his request to reside at district headquarter Orai and to attend the outlying Court daily at Jalaun after performing journey from Orai every working day i.e. to leave the place of posting every day, is on the discretion of the Hon'ble Administrative Judge of the judgeship as per prevailing practice.
