Accordingly, the matter was submitted before Hon'ble the Administrative Judge, Jalaun at Orai Judgeship through an office note dated 03.12.2009 (flag '2'). His Lordship has been pleased to pass an order dated 17.05.2011 (flag '3'), which is reproduced as below:-

"The request was made on 12.06.2009. A fresh report be called from the District Judge."

The order dated 17.05.2011 has been communicated to the District Judge, Jalaun at Orai through Court's letter dated 21.05.2011 (flag '4').

Now, in reply of this Court's letter dated 21.05.2011, the District Judge, Jalaun at Orai through his letter dated 01.06.2011 (flag '1') has submitted that Sri Munna Prasad, the then Civil Judge (Junior Division) has been transferred to district Chandauli under Hon'ble Court's Notification no. 637/ D.R.(S)/ 2011 dated 11.04.2011 and accordingly he has handed over charge on 15.04.2011. He has submitted the information for kind perusal of the Hon'ble Court.
