Ist and IInd years to this court for inclusion of qualification of L.L.M. In his service records placed below at **Flag 'A'**.

It may be recalled that earlier Government of U.P. through their letter dated 19.08.09 (at **Flag 'B'**) requested the court to send attested copy of certificate of L.L.M. and copy of application form of U.P. Nyayik Sewa of Sri Munna Prasad, the then Civil Judge (Jr. Div.), Deoria now Civil Judge(Jr. Div.), Chandauli. Therefore court's letter No. 13967/IV-3461/Admin.(A) dated 27.08.2011 was sent to District Judge, Chandauli with request to ask Sri Munna Prasad, Civil Judge (Jr. Div.), Chandauli to send attested copy (not self attested) of marksheet of L.L.M. Ist and IInd year and attested copy of final certificate of L.L.M. to this court for necessary action.

In reply of court's letter dated 27.08.2011, Sri Munna Prasad has submitted attested copy of final degree of L.L.M. and marksheet of L.L.M. Ist and IInd years which are at **Flags 'C', 'D' & 'E'** respectively to this court for necessary action.

In this connection, it is submitted that Appointing authority of Judicial Officers of State is Government of U.P. and Sri Munna Prasad has got appointment in U.P. Nyayik Sewa vide Notification No. 2430/II-4-06-32(1)/2001 TC dated 26.05.06 of Appointment Section-4, Government of U.P. (at **Flag 'X'**). He has completed his L.L.M. prior to his appointment in U.P. Nyayik Sewa. The qualification of L.L.M. may be included in the service records of Sri Munna Prasad, Civil Judge (Jr. Div.), Chandauli with the permission of Government of U.P. as the appointing authority of Judicial Officers is Government of U.P. Therefore, it seems proper the attested copy of final degree of L.L.M. and marksheets of L.L.M. Ist & IInd year and photocopy of form of U.P. Nyayik Sewa may be sent to the Government for obtaining orders.
