May kindly see the letter at flags 'A', received from Smt. Rekha Singh, Additional Civil Judge (Junior Division), Agra regarding grant of permission to visit Mauritius from 21.6.2010 to 10.07.2010.

In her letter, Smt. Rekha Singh has stated that 'Hindi Sahitya Academy, Mauritius' has invited her husband Dr. Vijay Kumar (Regional Transport Officer) and herself in connection with a lecture and therefore, she is willing to go to Mauritius with her husband to attend the function going to be held from 21.06.2010 to 10.07.2010. She has also submitted a copy of the 'Invitation letter' (flag 'B') of the President 'Hindi Sahitya Academy, Mauritius', in which it is mentioned that the Academy will provide facility of accommodation, food & medical care. She has, therefore, requested to grant her permission for the visit.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). As per reports, placed below, no vigilance / departmental enquiry is pending against Smt. Rekha Singh. Earlier, she had been issued 'Identity Certificate' to obtain Passport (Order at flag 'M'). From the instant letter, it appears that they have to bear the expenses of Traveling ticket only, about which the officer has not disclosed the details of expenses, but as the officer and her husband both are in government service, they appear to be capable enough to meet out the ticket expenses. Declaration to the effect that, there will be no possibility of arising any embarrassing position before Government of India or U.P. due to her foreign visit, no such request was ever refused to her and she has not visited any foreign country earlier, is at flag 'N'.

Under the facts and circumstances, mentioned above, if approved by Hon'ble Mr. Justice Vimlesh Kumar Shukla, Administrative Judge, Agra Judgeship, Smt. Rekha Singh, Additional Civil Judge (Junior Division), Agra may be granted permission to visit Mauritius with her husband from 21.06.2010 to 10.07.2010 to attend function of 'Hindi Sahitya Academy, Mauritius' there, subject to the conditions that proper charge of Government records or cash, if any, or any government property with her, may be handed over by her before proceeding abroad?
