May kindly see the letter dated 11.08.2010 at flags 'Z', as well as letter dated 24.07.2010 at flag 'A', received from Smt. Rekha Singh, Judicial Magistrate, Agra regarding grant of permission to go to London on 22.08.2010 to attend a marriage ceremony there.

In her earlier letter dated 24.07.2010 at flag 'A', Smt. Rekha Singh had stated that she has to go to London on 22.08.2010 with her husband to attend a marriage ceremony there and had requested to grant her permission to go to London. She had also enclosed a copy of 'Invitation Card' alongwith her letter, which may kindly be seen at flag 'AA'. On receipt of her letter dated 24.07.2010, after taking approval of Registrar General on 10.08.2010 (flag 'B'), she had been asked to furnish some information/ declaration immediately through fax, as prescribed in G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999, such as:-

1. Proposed period of stay at London.
2. Estimated expenditure of the visit on tickets, fooding, lodging etc. and as to how she bear the same?
3. Whether there is any possibility of arising any embarrassing position before the Government of India or the Government of U.P. due to her visit to the foreign country?
4. Whether such type of request was ever refused to her?
5. Details of her foreign visit(s), as she had been permitted to visit Mauritius from 21.06.2010 to 10.07.2010, vide this Court's letter no. 9573/ IV-3468/ Admin (A)/ Dated 11.06.2010.

Now, in reply of the Court's letter dated 10.08.2010, Smt. Rekha Singh, vide her letter dated 11.08.2010, sent through registered post, has stated pointwise that:-

1. She has to stay there for 4-5 days for marriage function.
2. She has to bear ticket expenditure only from her savings account and rest of the expenses on fooding lodging etc. will be borne at the residence of her relative/ friend.
3. If any problem will arise, she is responsible for that.
4. Earlier, no such request was refused to her.
5. Earlier, after taking permission of the Court, she had not visited Mauritius due to illness, information of which was already sent on 12.07.2010.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). As per reports, placed below, no vigilance / departmental enquiry is pending against Smt. Rekha Singh. Earlier, he had been granted permission to visit

Mauritius from 21.06.2010 to 10.07.2010 vide this Court's order dated 10.06.2010 (flag 'D'), but thereafter, vide letter dated 12.07.2010, received through fax on 12.08.2010 (flag 'E'), Smt. Rekha Singh has informed that she had not visited Mauritius due to her illness.

Under the facts and circumstances, mentioned above, if approved, the file be laid before Hon'ble Mr. Justice Vimlesh Kumar Shukla, Administrative Judge, Agra Judgeship for His Lordship's kind perusal & orders?
