May kindly see the letter, placed below at flag 'A', received from Smt. Rekha Singh, Additional Civil Judge (Jr. Div.), Mathura regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by her or any member of her family for the financial years 2010-11 & 2011-12 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial year 2010-11 & 2011-12 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2010-11, the income from salary and other sources is Rs.10,18,710/- and from this amount, Rs.1,22,020/- is deducted against CPF, Rs.1440 as GIS, Rs.83,280/- against Income Tax, Rs.32,748/- against LIC premium, Rs.1,00,000/- purchased NSC and Rs.48,000/- deposited in his R.D. Account. The balance of his savings bank account (s) enhanced for Rs.18,882/- (including interest). As such, total deductions/repayment/savings/ investment is Rs.04,06,370/- Thus, a sum of Rs.06,12,340/- was therefore available with her to meet out the household expenditure of her family consisting of four members in whole of the financial years 2010-11.

However, it is pertinent to mention here that her husband Dr. Vijay Kumar, is R.T.O., and his income is Rs. 8,92,000/- per annum.

(2) In the financial years 2011-12, the income from salary and other sources is Rs.10,22,244/- and from this amount, Rs.38,253/- is deducted against CPF, Rs.1920 as GIS, Rs.1,16,500/- against Income Tax, Rs.32,748/- against LIC premium, Rs.1,00,000/- purchased NSC and Rs.48,000/- deposited in his R.D. Account. The balance of his savings bank account (s) enhanced for Rs.3,94,968/- (including interest). As such, total deductions/repayment/savings/ investment is Rs.07,32,389/- Thus, a sum of Rs.02,89,855/- was therefore available with her to meet out the household expenditure of her family consisting of four members in whole of the financial years 2011-12.

However, it is pertinent to mention here that her husband Dr. Vijay Kumar's annual income is Rs.9,43,000/-

In this connection it is submitted that last time, Smt. Rekha Singh had submitted her property statement of the financial year 2009-10 (statement is at flag 'M'), which had already been seen by Hon'ble Mr. Justice Vimlesh Kumar Shukla, the then Administrative Judge, Agra on 31-03-2011 at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the year 2010-11 & 2011-12 in its next financial year i. e. in 2012-13 up to March 2013. She has submitted the same through letter dated 17-01-2014 and as such, there is ~~some~~ delay in submitting the said statements.

May, therefore, if approved, the property statements for the financial years 2010-11 & 2011-12 alongwith letter dated 17-01-2014 (flagged 'A') of Smt. Rekha Singh, Additional Civil Judge (Jr. Div.), Mathura be laid before Hon'ble Mr. Justice Sanjay Misra, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal and orders?
