May kindly see the letter, placed below at flag 'A', received from Smt. Rekha Singh, Additional Chief Judicial Magistrate, Allahabad regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by her or any member of her family for the financial years 2012-13 and 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

- (1) In the financial year 2012-13, the income from salary is Rs.6,33,519/-,, income from house rent is Rs.1,74,000/-, agricultural income is Rs.68,000/- and interest from savings accounts is Rs.83,178/-. Thus the total income comes to Rs.9,58,697/- and from this amount, Rs.2,200/- is deducted against GIS, Rs.60,650/- against Income Tax, Rs.32,748/- against premium of LIC policies, Rs. 24,000/- against R.D. and Rs.4,00,000/- against FDR and Rs.1,00,000/- deposited in his PPF account. As such, total deductions/ repayment/ savings/ investment is Rs.6,19,598/-. The balance of his savings bank account(s) decrease for Rs.33,160/- this financial year. Thus, a sum of Rs.3,72,259/- was therefore available with her to meet out the household expenditure of her family consisting of four members in whole of the financial year.

It is pertinent to mention here that her husband Dr. Vijay Kumar is working as R.T.O. and his annual income is Rs.9,37,956/-.

- (2) In the financial year 2013-14, the income from salary is Rs.7,45,893/-, income from house rent is Rs.1,83,000/-, agricultural income is Rs.72,000/- and interest from savings accounts is Rs.89,478/-. Thus the total income comes to Rs.12,72,170/- and from this amount, Rs.2,400/- is deducted against GIS, Rs.1,03,163/ against CPF, Rs.1,04,036/- against Income Tax, Rs.32,748/- against Premium of LIC policies, Rs.24,000/- against R.D. and Rs.1,00,000/- deposited in his PPF account. As such, total deductions/ repayment/ savings/ investment is Rs.03,66,347/-. The balance of his savings bank account(s) decrease for Rs. 1,81,799/- this financial year. Thus, a sum of Rs. 7,05,823/- was therefore available with her to meet out the household expenditure of her family consisting of four members in whole of the financial year.

It is pertinent to mention here that her husband's annual income is

Rs.10,07,587/-.

In this connection it is submitted that Smt. Rekha Singh has already submitted his property statement up to the financial year 2011-12 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Sanjay Misra the then Administrative Judge Mathura on 06.03.2014 at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2012-13 & 2013-14 in its next financial year i.e. 2014-15 upto March 2015. She has submitted the movable and immovable property statement vide her letter dated 05.11.2014. As such, he has not submitted the aforesaid statements within due time for which which she has regretted in her letter dated 05-11-2015 (flag 'A').

May, therefore, if approved, the property statements for the financial years 2012-13 and 2013-14 alongwith letter dated 05-11-2015 (flagged 'A') of Smt. Rekha Singh, Additional Chief Judicial Magistrate, Allahabad be laid before Hon'ble Mr. Justice Pankaj Mithal, Administrative Judge, Allahabad Judgeship for His Lordship's kind perusal and orders?
