May kindly see the letter, placed below at **flag 'A'**, received from Smt. Rekha Singh, Additional Chief Judicial Magistrate, Hathras regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by her or any member of her family for the financial years 2014-15 and 2015-16 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial year 2014-15, income from salary and different arrears is Rs.6,88,072/-, income from agriculture is Rs.65,000/-, income from house rent is Rs.2,14,000/- and income from interest & others is Rs.75,424/-. Thus, the total amount is Rs.10,42,496/- and from this amount, Rs.61,439/- is deducted against CPF, Rs.1,800/- against GIS, Rs.87,526/- against Income Tax, Rs.2,22,00/- against NSC, Rs.32,748/- against premium of LIC policies and Rs.1,50,000/- deposits in her PPF Account. As such, total deductions/ repayment/ savings/ investment is Rs.5,55,513/-. The balance of her savings bank account(s) reduced for Rs.1,31,993/- this financial year from last year's balance. Thus, a sum of Rs.6,18,976/- was therefore available with her to meet out the household expenditure of her family consisting of four members in whole of the financial year.

It is pertinent to mention here that her husband is R.T.O. and his gross annual income is Rs.12,17,764/- (approx.).

(2) In the financial year 2015-16, income from salary and different arrears is Rs.9,94,332/-, income from agriculture is Rs.65,000/-, income from house rent is Rs.84,000/- and income from interest & others is Rs.1,40,007/-. Thus, the total amount is Rs.12,83,339/- and from this amount, Rs.39,890/- is deducted against CPF, Rs.2,000/- against GIS, Rs.1,08,901/- against Income Tax, Rs.1,00,000/- against NSC, Rs.32,748/- against premium of LIC

policies, Rs.1,00,000/- against Home loan and Rs.1,50,000/- deposits in her PPF Account. The balance of her savings bank account(s) enhanced for Rs.2,07,538/- this financial year from last year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.7,41,077/-. Thus, a sum of Rs.5,42,262/- was therefore available with her to meet out the household expenditure of her family consisting of four members in whole of the financial year.

It is pertinent to mention here that her husband is R.T.O. and his gross annual income is Rs.14,22,984/- (approx.).

In this connection it is submitted that Smt. Rekha Singh has already submitted her property statement upto the financial year 2013-14 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Shasi Kant Gupta, the then Administrative Judge, Allahabad at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2014-15 & 2015-16 in its next financial year i.e., 2016-17 upto March 2017. She has submitted the movable and immovable property statement for the financial year 2014-15 & 2015-16 vide her letter dated 22.06.2017 (at flag 'A'). As such, there is delay in submitting the aforesaid property statements from the part of the officer for which she has regretted and apologized for late submission of aforesaid property statements.

May, therefore, if approved, the property statements for the financial years 2014-15 & 2015-16 alongwith letter dated 22.06.2017 (at flag 'A') of Smt. Rekha Singh, Additional Chief Judicial Magistrate, Hathras be laid before Hon'ble Mr. Justice Ashok Kumar, Administrative Judge, Hathras Judgeship for His Lordship's kind perusal and orders?
