May kindly see the letter at flag 'A' & 'A-1', received from Smt. Rekha Singh, Additional Civil Judge (Jr. Div.), Agra regarding grant of permission to sell immovable property i.e. plot, situated at Kasganj, District Kanshi Ram Nagar.

In her letters, Smt. Rekha Singh has stated that she wants to sell her plot measuring ^{about} 248 sq. meters, situated at Kasganj, District Kanshi Ram Nagar due to some financial reasons. The proposed purchasers of the plot are Smt. Archana W/o Sri Sarvottam and Smt. Rekha W/o Sri Chandra Prakash, residents of Nadrai Gate, Kaasganj, District Kanshi Ram Nagar and the sale price of the plot is Rs. 8,85,000/-. The purchasers are not related to him in any way and no case of the purchasers is pending or decided in her Court. She has, therefore, requested the Court to grant her permission to sell the plot in question.

In this connection it is submitted that the officer has already shown the plot in her Property statement (flag 'B'). It is further submitted that in term of Rule 24(1) of U.P. Government servants' conduct Rule-1956-

"No Government servant shall, except with the previous knowledge of the appropriate authority acquire or dispose of any immovable property by lease, mortgage, purchase, sale, gift or otherwise, either in his own name or in the name of any member of his family;

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

It is further submitted that under the provision of above rule, the permission, as requested by the officer may be granted, if the Hon'ble Court deem fit and proper.

May, therefore, if approved by the Hon'ble Mr. Justice M.I.Murtaza, permission be accorded to Smt. Rekha Singh, Additional Civil Judge (Jr. Div.), Agra to sell her plot measuring ^{about} 248 sq. meters, situated at Kasganj, District Kanshi Ram Nagar to Smt. Archana W/o Sri Sarvottam and Smt. Rekha W/o Sri Chandra Prakash, residents of Nadrai Gate, Kaasganj, District Kanshi Ram Nagar for a sum of Rs. 8,85,000/-, as requested, subject to the conditions that she should submit the relevant papers of the transaction after its completion?
