May kindly see the letter, placed at flag 'A' received from Sri Jitendra Singh, Additional Civil Judge (Junior Division), Budaun regarding issuance of 'Identity Certificate' for obtaining Passport.

*Request-104*

In his letter, Sri Singh has stated that there may be a possibility for him to visit abroad in future due to some need and, therefore, he want to obtain Passport for himself, for which 'Identity Certificate' is required from the Hon'ble Court as per Passport Rules. His dependents are Mrs. Sunita Singh (Wife) and Ms. Era Singh (daughter). He is enclosing four passport size photographs of himself and required 'Affidavit' (flag 'B') in connection with declarations as per G.O. and Section 6 (2) of Passport Rules. He has, therefore, requested for placing his application before the Hon'ble Court for issuance of 'Identity Certificate' in his favour for obtaining Passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). He has requested for issuance of 'Identity Certificate' from the Court. As per reports, placed below, no vigilance/ departmental enquiry is pending against Sri Jitendra Singh. His request is considerable, as he has submitted required details and papers in this connection.

Under the facts and circumstances, mentioned above, if approved by Hon'ble Mr. Justice S.S. Chauhan, Administrative Judge, Budaun Judgeship, the 'Identity Certificate' at flag 'D' be issued, in duplicate, in favour of Sri Jitendra Singh, Additional Civil Judge (Junior Division), Budaun, as requested, for obtaining Passport with the direction that he should take prior permission of the Court before proceeding abroad?
