May kindly see the letter at flags 'A' and 'A-1' (through fax), received from Sri Jitendra Singh, the then Civil Judge (Senior Division), Amroha presently posted as Secretary, District Legal Services Authority, Amroha regarding issuance of fresh 'Identity Certificate' in his favour for obtaining Passport.

In his letters, Sri Singh has stated that there may be a possibility for him to visit abroad in the future due to some need, therefore, he wants to obtain passport for which 'Identity Certificate' is required from the Hon'ble Court as per passport rule. He has also stated that he has been issued 'Identity Certificate' from the court in 2012 but due to expiry of the same, he can not obtain passport, furthermore, the earlier issued 'Identity Certificate' is never used by him anywhere. Smt. Sunita Singh (Wife), Km. Era Singh and Km. Gauri Singh (Daughters) are dependent family members of the officer. He has also enclosed passport size photographs of himself and required details/ declaration on 'Affidavit', which may kindly be seen at flag 'B'. He has, therefore, requested to place his application before the Hon'ble Court for issuance of 'Identity Certificate' in his favour for obtaining Passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). Here, it is also to submit that as per reports, placed below, no vigilance/ departmental enquiry is pending against Sri Jitendra Singh. Earlier as per approval dated 20.09.2012 (flagged 'X') of Hon'ble Administrative Judge, Budaun, the officer has been issued 'Identity Certificate' (office copy, at flag 'X-1'), communicated to him Vide Court's letter dated 26.09.2012 (flagged 'E') but as the officer has stated that earlier issued 'Identity Certificate' is never used by him anywhere and due to expiry of the earlier issued certificates and he could not obtain passport till now, his request appears to be considerable, as he has submitted required details and papers in this connection.

Under the facts and circumstances, mentioned above, if approved by Hon'ble Mr. Justice Pritinker Diwaker, Administrative Judge, Amroha, the fresh 'Identity Certificate' at flag 'D' be issued, in duplicate, in favour of Sri Sri Jitendra Singh, presently posted as Secretary, District Legal Services Authority, Amroha, as requested, for obtaining Passport with the direction that now he should apply for the passport within due time and that he should take prior permission of the Court before proceeding abroad?
